Under limited supervision, examines construction documents for buildings to enforce building, electrical, mechanical, model energy, fuel gas, plumbing, fire, zoning, disability and related codes within area of certification; informs design team regarding code requirements; interprets architectural/engineering drawings; and performs related duties as assigned to enforce compliance with all codes, regulations and ordinances; researches new construction materials and methods; and provides information to and works with the clients to resolve issues related to code compliance.

- Review complex plans to ascertain compliance with applicable codes, standards and regulations.
- Examine plans and specifications of new construction, additions and alterations to projects to determine compliance with the provisions of applicable construction codes, ordinances and regulations.
- Confer with architects, contractors, builders and the general public; explain and interpret building requirements and restrictions.
- Researches codes for approval or disapproval of submitted plans, especially in unusual or unique installations.
- Draft correspondence to comply with code requirements and maintain records of history of facts. Explain regulations and recommend rectifications.
- Reviews new materials and methods used in building construction; attends training courses to learn of new codes and other inspection regulations; takes an active part in the training process.

- Perform preliminary review of assigned projects to identify potential problems and recommend alternative solutions; records existing site conditions; attends pre-construction and design review meetings.
- Review, interpret plans, blueprints, site layouts, specifications, and construction methods to ensure compliance to legal requirements and safety regulations.
- Measure dimensions and verify level, alignment, and elevation of structures and fixtures to ensure compliance to building plans and codes.
- Knowledge of Building, Electrical, Plumbing, Mechanical, Fire and general construction codes. Ability to prioritize, multi-task and meet deadlines.
