There appears to be less revenue available than previously expected. *Note:* The Legislative Budget Board (LBB) acts *only* as an interim committee. Edits/adjustments were made to the budget by the Lt. Governor after it was received from the LBB. *Note:* The House has provided additional funding for education; the Senate did not. The revenue shortfall is attributed to the reduced income from oil & gas production.

HB 265 has been filed by Representative Ana Hernandez. The bill is regarding the composition of the board of trustees for the Employees Retirement System (ERS) of Texas, stating that one member of the board may be a retiree. {note from MM-moved this from sunset review tab}

Consider Creation of New Standing Committee – Board Nominations and Development Bill Hamilton stated he was considering a committee to be focused on board nominations and board development. He circulated the following book for review by the board: *The Ultimate Board Member's Book*.
