Chaplain Rick Pustka

This past February our Commandant Jan Denney asked me to stand in as Chaplin for the Department while Bob Patterson plans an out of state move.

On the day Jan called me, I was reminded that on this same date, only 75 years earlier, January 3, 1943, the USAT Dorchester, steaming across frigid U-boat invested waters in the North Atlantic when suddenly a German torpedo struck near the engine room, triggering a massive explosion. The transport vessel, which was caring more than 900 soldiers and crew bound for Greenland, capsized and sank in less than 20 minutes. As the ship sank, panic-stricken and wounded were calmly aided into lifeboats by four ordinary men who handed their own lifejackets to the wounded. Survivors caught a final glimpse of the four men standing on a slanted deck, arms locked singing hymns as the ship slipped beneath the waves. More than 670 died that day.

Four ordinary guys from diverse backgrounds each motivated by a profound love of God, country and neighbor. Each one volunteering to serve their country following the tragedy of Pearl Harbor. Known as "The Four Chaplains" these men from different religious traditions rose to the occasion in a life-and-death crisis working together at a moment's notice to serve others. All four received, posthumously, the Distinguished Service Cross and Purple Heart.

We are losing members of the "Greatest Generation." They went from living through the Great Depression to fighting for our survival in WWII.



Let each of us remember: Lt. John P. Washington, a Catholic priest; Lt, Alexander D. Goode, a Rabbi; Lt. Clark V. Poling, a Reformed minister; and Lt. George L. Fox, a Methodist minister. These four men are only one example of Chaplains who served honorably, some more who come to mind include: Fr. Emil Kapaun, (a Kansas native) Korea; and Fr. Angelo J. Litekey, Vietnam. Chaplains are bound to our Marine Corps as Brothers; their inclusion is our Honor.

I am humbled to be your Chaplin this year and will do my best to honor the office.

Marine Corps History

12-13 April 1918: Marines of the 4th Brigade suffered their first gas attack on the night and early morning hours of 12-13 April when the Germans bombarded the 74th Company, 6th Marines near Verdun with mustard gas. Nine Marine officers and 305 enlisted Marines were gassed and evacuated, and 30 Marines died from the effects of the gas shells which hit in the middle of the reserve area cantonments in which they were sleeping.

15 April 1962: Marine Corps operational involvement in the Vietnam War began on Palm Sunday when HMM-362 with its Sikorsky UH-34s arrived at Soc Trang in the Delta south of Saigon. The task unit was called "Shufly" and its first operational employment involved lifting Vietnamese troops into battle.

21 April 1951: Marine carrier-based airplanes made their first aerial contact with enemy planes over the Korean front lines. Captain Philip C. Delong shot down two YAK fighters and 1st Lieutenant Harold D. Daigh destroyed one more and damaged another in the heavily defended Pyongyang-Chinnanpo area. Both pilots were with VMF-312 flying from the USS Bataan.

27 April 1805: First Lieutenant Presley N. O'Bannon, who with seven other Marines was part of a force of Greeks and Arabs led by American Consul William Eaton, raised the United States flag for the first time over a conquered fortress of the Old World at Derne, a stronghold of the Tripolitan pirates. Two

Marines were killed and one wounded in the assault on the walled city.
