





(January 2022)..... The Labor Department reports non-farm payrolls increased by 199 thousand in December while, in a separate survey, the nation's unemployment rate decreased from 4.2 percent to 3.9 percent. Approximately 168 thousand returned to the labor force while the civilian population increased 107 thousand. The number of employed increased 651 thousand. The number of long-term unemployed (>27 weeks) decreased 185 thousand to 2.0 million people, or 38 percent of the unemployed. Approximately 61.9 percent of the civilian population made up the labor force and about 59.5 percent of the population was employed.

The nation's underemployment rate (jobless, part-time desiring full-time and those deferring search over past 60 days) fell from 7.7 percent to 7.3 percent, to about 11.8 million people. Over the past year, private payrolls have increased 6.0 million people while average hourly earnings has increased by \$1.40, or 4.7 percent.

Strategically... The data shows that after losing over 20.4 million private sector jobs during the initial pandemic, the economy has recovered only about 17.7 million jobs, or about 87% of the jobs lost. More concerning, about 2.2 million people have not returned to the labor force. Open positions are abundant and yet employers continue to have difficulty filling them.

The tepid December jobs report adds to growing evidence the recovery has slowed, but it probably won't deter the Federal Reserve from announcing plans soon to start to wean the economy off its easy-money strategy and start to battle its elevated inflationary environment.
