Dear Friends and Parents:

It's great to be writing to you about dance classes this winter!

We're all in this together as we endeavor to make life as safe and also as enjoyable as possible.

It's a privilege to teach your children. That privilege is a responsibility I have always taken seriously. In today's world we all have more collective responsibility than ever before.

As with our fall session that just wrapped up this winter Bronxville Ballet will be doing a lot to try and ensure everyone's collective safety. We will once again be turning to the CDC guidelines for protocols about teachers or dancers who might be exhibiting symptoms of COVID-19 and also to determine what to do if a teacher, student or someone in a teacher or dancer's home tests positive for COVID-19.

We will be decreasing density and maintaining social distancing during class - staying 6' apart and wearing face coverings—so as to avoid coming into “close contact”.* There will, of course, be lots of focus on hygiene—hand washing and also sterilization of any common use/touch items. And, we will all be staying in close communication as the semester goes on.

It is also up to each of us to constantly give notice if we or anyone we will be coming into contact with show signs of or has tested positive for COVID-19.

So that I can stay well and continue teaching I've asked my husband and son to do more since they are part of my “close contact” environment. They are limiting their exposure to others, wearing face coverings, avoiding any state-to-state travel that would put them at greater risk or would trigger a mandated quarantine. I ask all of you to be mindful of your interactions as well since perhaps at no time before this has each of our behaviour had such a direct impact on others. If any of us is not being socially-distant and wearing a face covering, everyone (and our classes) are at greater risk.

WAIVER AND INDEMNIFICATION — Bronxville Ballet, Inc.

Although every effort is made to create a safe environment, I acknowledge that dancing is an activity which involves inherent risks. I, my child(ren) and those in our home assume the risks of participating in **Bronxville Ballet** and its various forms of instruction in its various locations and forever waive, release, discharge and indemnify **Bronxville Ballet**, Ana R. Dimas, **The Bronxville Women's Club**, any of their employees, independent contractors, volunteers, third parties, and or affiliates of any kind (collectively, “**Bronxville Ballet**”) from all liability for any damage, loss or injury arising out of my child(ren)'s participation in Bronxville Ballet's programming irrespective of location or the form of instruction.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of large groups of people.

Bronxville Ballet has put in place certain preventative measures to hopefully reduce the spread of COVID-19. However, I understand that **Bronxville Ballet** can in no way guarantee that I, my child(ren) or anyone in my home will not become infected with COVID-19. Further, I understand that attending **Bronxville Ballet**, irrespective of the location or form of instruction, could increase my risk, my child(ren)'s risk and the risk of anyone in my home of contracting COVID-19.

I understand that if my child exhibits any symptoms of COVID-19 or has tested positive for COVID-19 I cannot nor will not bring them to class.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I, my child(ren) and anyone in my home may be exposed to or infected by COVID-19 by attending **Bronxville Ballet** programming in any location and that such exposure or infection may result in personal injury, illness, permanent disability, and even death. I understand that the risk of becoming exposed to or infected by COVID-19 at **Bronxville Ballet** may result from the actions, omissions, or negligence of myself and others, including, but not limited to, **Bronxville Ballet** and or The Bronxville Women's Club, either of their employees, independent contractors, volunteers, third parties and or affiliates of any kind, and or from program participant, their families or caregivers.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren), myself or anyone in our home (including, but not limited to, personal injury, disability, and even death), illness, damage, loss, claim, liability, or expense, of any kind, that I, my child(ren) or anyone in our home may experience or incur in connection with my child(ren)'s attendance at **Bronxville Ballet** or participation in **Bronxville Ballet** programming ("Claims") irrespective of the location or form of instruction. On my behalf, on behalf of my child(ren), and anyone in my home I hereby release, covenant not to sue, discharge, and hold harmless **Bronxville Ballet**, any and all of its representative as well as The Bronxville Women's Club, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of **Bronxville Ballet** and or The Bronxville Women's Club whether a COVID-19 infection occurs before, during, or after participation in any **Bronxville Ballet** program irrespective of its form or location. Despite my agreement to not sue **Bronxville Ballet**, its owner, employee(s), independent contractors, volunteers, or third parties, or, The Bronxville Women's Club, its employees, volunteers or third parties, I understand that should I still initiate a law suit(s) or any similar action(s) against any of those parties I shall be responsible to pay for all of the defendants' costs, necessary disbursements and attorney fees plus loss of time incurred in enforcing and defending this waiver, indemnification and release and recognize that I may be counter-sued for damages resulting from my suit irrespective of its outcome.

But for our 50% virtual refund for classes not held in person, there are no refunds of any kind whatsoever. **Bronxville Ballet** may cancel classes due to government order, the decision of The Bronxville Women's Club, and or based upon the sole and absolute discretion of **Bronxville Ballet**. In any of the preceding instances there shall be no refund of any kind whatsoever.

I have read and understand this waiver, indemnification and release and I fully understand its contents. I further understand that if my child(ren) display(s) any symptoms such as fever, cough, sniffles/runny nose, upset stomach, shortness of breath, or does not feel well they cannot attend class and that there will be no refund(s). In addition, I understand that any child(ren) who arrives for class exhibiting or during class exhibits any of the preceding signs of illness will not be allowed to participate at the sole and absolute discretion of **Bronxville Ballet** and that there will be no refund if a child(ren) is denied participation prior to, during class, or for any required period of quarantine.

I hereby grant **Bronxville Ballet** the right the use, re-use, publish and re-publish photographic portraits or pictures of the child(ren) for the express purpose of marketing, promoting and creating the public image of its dance instruction.

I warrant that I am of full age and have every right to contract for the child(ren) in the above regard. I state further that I have read the above authorization, release, and indemnification agreement, prior to its execution and that I am fully familiar with the contents. This release shall be binding upon me and my heirs, legal representatives and assigns.

Bronxville Women's Club Waiver of Liability Relating to Coronavirus/COVID-19 (Child/Children)

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact, by contact with contaminated surfaces and objects, and in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. All of the methods of spread and contraction are unknown, and there is no known remedy, cure, or vaccine for COVID-19. Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death.

The Bronxville Women's Club, Inc, ("Bronxville Women's Club") is complying with CDC and New York State COVID-19 regulations and guidelines in accordance with instructions from the Bronxville Police Department. The Bronxville Women's Club cannot prevent you from becoming exposed to, contracting, or spreading COVID-19 while utilizing the Bronxville Women's Club's services or premises. It is not possible to prevent against the presence of the disease. Therefore, if you choose to utilize the Bronxville Women's Club's services and/or enter onto the Bronxville Women's Club's premises you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

Assumption of Risk: I have read and understand the above warning concerning COVID-19.

I hereby choose to accept the risk of contracting COVID-19 for myself, my child (children) and my invitees in order to utilize the Bronxville Women's Club's services and enter the Bronxville Women's Club's premises. These services are of such value to me, that I accept on behalf of myself, my child (children) and invitees the risk of being exposed to, contracting, and/or spreading COVID-19 in order to utilize the Bronxville Women's Club's services and premises in person. I will immediately notify Bronxville Women's Club in writing if I, my child (children) and/or any invitee get sick with or test positive with COVID-19, show symptoms of COVID-19 or have close contact with any person who has COVID-19.

WAIVER OF LAWSUIT/LIABILITY: I hereby forever release and waive my right to bring suit against the Bronxville Women's Club and its officers, directors, members, guests, managers, agents, employees, or other representatives, independent contractors, service providers, invitees and visitors ("BWC parties"), each of whom constitutes an intended third party beneficiary, in connection with exposure, infection, and/or spread of COVID-19, related to utilizing the Bronxville Women's Club's services and premises. I understand that this waiver means I give up my right to bring any claims, including for personal injuries, death or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, provided that "gross negligence" shall not include any claims for or in the nature of or based on lack of improper or negligent supervision of Bronxville Ballet or any activities of Bronxville Ballet in the premises, including examination or review with respect to physical distancing, face covering, hand hygiene, or other safety requirements or protective measures, or other oversight of any COVID-19 related rules, practices, policies or precautions of Bronxville Ballet in the premises, as to which the Bronxville Women's Club will rely upon Bronxville Ballet for implementing, regulating and enforcing COVID-19 regulations or guidelines or any related provisions of the Rental Agreement. Despite my agreement to not sue Bronxville Women's Club, and the BWC parties, I understand that should I still initiate a law suit(s) or any similar action, I shall be responsible to pay for all of the defendant's/defendants' costs and necessary disbursements and attorneys' fees plus loss of time incurred in enforcing and defending this waiver and release and recognize I may be counter-sued for damages resulting from my suit irrespective of its outcome.

CHOICE OF LAW: I understand and agree that the laws of the State of New York will apply to this document.

I HAVE CAREFULLY READ AND FULLY UNDERSTAND ALL PROVISIONS OF THIS RELEASE, AND FREELY AND KNOWINGLY ASSUME THE RISK AND WAIVE MY RIGHTS CONCERNING LIABILITY AS DESCRIBED ABOVE.
