2019 NJOMA Election Procedures Candidacy Deadline: March 5, 2019 at 5:00 pm

NJOMA Bylaws Article V – Board of Directors

Section 1 Composition: The NJOMA Board of Directors shall consist of representatives from each Region and four (4) At-Large. Any member of the Association that desires to change the number of members of the Board of Directors to ensure the efficient operation of the Association must adhere the Article XII criteria.

Elections will take place at the 2019 NJOMA Conference for the following three (3) Regions and two (2) At-Large positions:

Region 3a Northwest At-Large
Region 6 National At-Large
Region 8

Filing for Candidacy:

- 1. All candidates must attend the 2019 NJOMA Conference.
- 2. All candidates must have paid full registration by filing deadline of March 5, 2019.
- 3. Candidates must submit a written Declaration of Candidacy and pay a \$20 fee by filing deadline of March 5, 2019.
- 4. Candidates must adhere to the procedures outlined in the Election Procedures.
- 5. Candidates must attend scheduled Caucus meetings.
- 6. Potential candidates must attend the Board Candidate Orientation Workshop.
- 7. If elected to the NJOMA Board of Directors, members must attend the mandatory NJOMA Board of Directors' meeting on Thursday, March 7, 2019 at 9:00 a.m.

Election Protests:

The Election Committee will consider any election protest filed by a declared candidate submitted before 1:00 p.m. on the final day of the conference. Following the protest filing deadline, the Election Committee will meet and render a decision within one (1) hour. The decision of the Election Committee will be final.
