

The May 11, 2020 meeting of St. Albans Township was called to order by Chairman, Randal Almendinger.

All trustees and fiscal officer were present.

The minutes of the April meeting were read and approved as read.

The fiscal officer read fund balances to date.

Charlie Montgomery updated trustees on maintenance that needs done on roads and properties for drainage from all the rain that we have had, a tree on Watkins road that needs removed and the estimate from Brian Dague is \$1800.00, Salt spreader is going to need replaced in another year and the mower is currently being worked on and hoping to make it through this year with it, but it needs replaced.

Tom Frederick gave the April zoning report and presented trustees with information of an application for a zoning change that a public hearing will need to be held for.

Bruce Lane made a motion to hold a public hearing on June 8th 2021 at 6:30 P.M. for Keri Dixon for a re-zoning request for the property at 6290 Worthington Rd. Alexandria, Ohio from Ag to General Business.

2nd by Jean Morrison. Roll call: Jean Morrison -yes, Bruce Lane -yes, Randal Almendinger -yes. Motion carried.

Mike Theisen gave the April Fire and EMS reports.

Mike asked trustees if they looked over the website information that he talked about at the April meeting and what their thoughts were. Trustees asked Mike to continue to work on it.

Mike said he and Chief Wright from Monroe Township have talked about the Liberty Township levy. They would like to ask for a renewal plus an increase, which will generate approximately \$497,747.00

Trustees put on the November ballot a 3.1 renewal with a 2 mill increase for a total of 5.1 mills for fire protection.

2nd by Jean Morrison. Roll call: Jean Morrison -yes, Bruce Lane -yes, Randal Almendinger -yes. Resolution passed.

Bruce Lane made a motion to accept the resignations for the fire department from the following individuals: Owen Rodeniser, Jacob Castle, Nick Haugen, Grant Ellis, and Jacob Rutherford effective immediately and Mike Starling effective May 24, 2021.

2nd by Jean Morrison. Roll call: Jean Morrison -yes, Bruce Lane -yes, Randal Almendinger -yes. Motion carried.

Jean Morrison made a motion to hire the following individuals at the fire department: Steve Cossin, and Justin Mooney, both Firefighter/Medic and Austin Hurst, Firefighter/EMT.

2nd by Randal Almendinger. Roll call: Jean Morrison -yes, Bruce Lane -yes, Randal Almendinger -yes. Motion carried.

Bruce Lane said the electrician is currently working in the new township building.

Trustees discussed what road maintenance to do for 2021 after receiving the engineers estimates.

Bruce Lane made a motion to advertise for road bids for a leveling coat/tar and chip with berms on Watkins Rd. from Weslyn Church to Old Worthington Rd. Bids will be due by June 5, 2021 at 12:00 P.M. and opened on June 8, 2021 at 7:00 P.M. at the St. Albans Township Fire Station Community Room, and for this to be advertised in the Newark Advocate.

2nd by Randal Almendinger. Roll call: Jean Morrison -yes, Bruce Lane -yes, Randal Almendinger -yes. Motion carried.

Trustees talked about specs for a new mowing tractor.

Checks were signed.
