The affidavit should state that you were not driving, explain whether the vehicle was sold, stolen, or driven by another person (including their name, license number, and contact information, if known), and include any supporting evidence, such as a police report, proof of your location, or a statement from the actual driver. Upon review, the citation may be dismissed or transferred to the responsible party.

Please write clearly and make sure you record the information accurately.
