Every licensee shall provide evidence, satisfactory to the Local Liquor Control Commissioner, of the issuance of a policy of liquor liability insurance (Dram Shop) and a policy insuring against general liability for any injury or death on account of acts of negligence, omission, or in violation of the Liquor Control Act. Said general liability policy shall carry a minimum of $\$ 50,000$ per person and $\$ 100,000$ per occurrence for injury or death; the Dram Shop policy shall cover the maximum amount of potential liability as provided by State law. Each licensee shall furnish the Local Liquor Control Commissioner a certificate of such insurance and, in the event of cancellation, immediately notify the Local Liquor Control Commissioner of such cancellation in writing. Upon such cancellation, the licensee shall suspend business operations.

## § 111.16 LICENSE CLASSIFICATIONS, FEES, NUMBER ISSUED.

## Class A.

Description. Authorizes the retail sale on the licensed premises specified of alcoholic liquors, spirits, wines, beer, ale or other liquids containing more than one-half of one percent of alcohol by volume for consumption on the licensed premises specified;
Application fee: $\$ 1,300$; Annual renewal fee: $\$ 1,050$;

## Class A-2

Description. Authorizes the retail sale on the licensed premises specified of beer, ale, and wine only, but no other alcoholic liquors for consumption on the licensed premises;

Application fee: \$1,175;
Annual renewal fee: \$925;

## Class B.

Class B-1
Description. Authorizes the retail sale on the specified licensed premises of alcoholic liquor for consumption on the premises only. This license only applies to establishments known as restaurants. A restaurant for purposes of this license is any public place kept, used, maintained and held out to the public as a place where meals are prepared and served for consumption on-site, such space being provided with adequate and sanitary kitchen and dining room equipment and capacity and having employees therein, a sufficient number and kind of employees to prepare, cook and serve suitable food for its guests. This license shall only apply to such establishments as defined herein and where the gross sales of liquor do not exceed 40\% of the overall gross receipts of the business.

Servers. Authorizes employees of the age of 19 years or older to take and deliver liquor order on the premises. Employees must be 21 years of age or older to pour liquor or receive payment for the sale of liquor.

Application fee: $\$ 1,275 . \quad$ Annual renewal fee: $\$ 1,025$.

## Class B-2

Description. Same as B-1 license description except that a B-2 license shall authorize the retail sale on the specified licensed premises of beer, ale and wine only. No other alcoholic liquors are permitted.

## Class C.

## Class C-1

Description. Authorizes the retail sale of alcoholic liquors for consumption only on the licensed premises specified and which shall be issued only to a regularly organized veterans or service-persons' club or not-for-profit organization maintaining permanent club quarters irrespective of the size of their membership and having a national or state charter.

Application fee: $\$ 700$ Annual renewal fee: $\$ 450$.

## Class C-2

Package sales, live entertainment, outdoor sales provisions applicable to $A-1, A-2, B-1, B-2$ and C-1 licenses. Any license other than D-1, D-2, D-3, and E-1, may by paying an additional fee or fees as follows apply for, but shall not be entitled to as a matter of right the following additional annual permits which shall be ancillary to their respective license:

- Package sales—Defined. Authorizes the retail sale for those permitted beverages authorized by the respective license of original, unopened containers and packages only for consumption away from the licensed premises.

Annual additional fee: $\$ 250$.

- Live entertainment. Authorizes the licensee to provide live indoor entertainment.

Annual additional fee: $\$ 250$.

- Outdoor sales. An additional permit to allow for the onsite outdoor sales and consumption of authorized beverages in separately cordoned areas contiguous to the building of the licensed premises excluding the public way and sidewalks with approval by the liquor commissioner after presentation and approval by the building inspector of a specific site plan designating the placement of same.

## Class D.

## Class D-1

Description. Authorizes the retail sale of alcoholic liquors, spirits, wine, beer, or ale, in original unopened containers and packages only for consumption away from the licensed premises specified, for an establishment commonly known as a package liquor store.

Application fee: $\$ 1,275$. Annual renewal fee: $\$ 1,025$.

## Class D-2 licenses:

Description. Authorizes the retail sale on the licensed premises specified of beer, ale or wine only, but no other alcoholic liquors in original unopened containers and packages only for consumption away from the premises.

Application fee: $\$ 1,150$. Annual renewal fee: $\$ 900$.

## Class D-3 licenses:

Description. Authorizes the retail sale of alcoholic liquors, spirits, wine, beer, or ale, in original unopened containers and packages only for consumption away from the licensed premises specified, as well as the retail sale of beer, ale, and wine for consumption on the specified premises. This license would allow the operation of a liquor store with the allowance of serving beer, ale, and wine for consumption on the premises for the primary purpose of accommodating statutorily authorized video gaming machines. Consumption on premises shall be confined and limited to the restricted area immediately surrounding the gaming machines.

Application fee: $\$ 1,275$.
Annual renewal fee: $\$ 1,025$.

## Class $E$

(1) Licenses also known as Special Event Licenses which shall authorize the retail sale on the licensed premises specified of alcoholic liquors, spirits, wine, beer, ale or other liquids containing more than one-half of one percent of alcohol by volume for consumption on the premises when sold by a not-forprofit organization for not more than a 24 -hour event. Class E licenses may be issued for the entire year for those dates designated by the applicant in advance, but in no event shall the applicant be permitted more than 12 such 24 -hour events per year. In the event that during the year, the applicant wishes to change said date or dates for such 24 -hour events, then the applicant shall in advance notify the Local Liquor Control Commissioner of the village, in writing, and only upon the written approval of the Local Liquor Control Commissioner shall the modification or change be permitted.
(2) Anything in the above paragraph to the contrary notwithstanding, there is hereby authorized a Special Event License for the benefit of not-for-profit corporations, voluntary nonprofit associations, church groups, and not-for-profit organizations. The cost of the Special Event License shall be $\$ 75$ and shall only be good for a 24 -hour period. No group, as defined above, may obtain a Special Event License for more than 12 days in any Municipal fiscal year (May 1 to April 30 of the following year), nor may any such Special Event License be applied for more than three consecutive days in a row nor more than six days out of 14 consecutive days. Such Special Event Licenses shall be issued upon application to, upon approval of, the Local Liquor Control Commissioner. Application shall be accompanied by the fee of $\$ 75$.
(3) Applications for a Class E license shall contain the following information:
(a) The name of the sponsoring organization;
(b) The name and address of a responsible officer of that organization;
(c) The police number, name and amount of coverage of appropriate dram shop insurance;
(d) The premises on which the license shall be utilized;
(e) A copy of the State Charter, if any;
(f) A copy of the appropriate State license;
(g) Such other information as is reasonably required by the Local Liquor Control Commissioner.
