Sealed Bids for the construction of **"Ida Tree/Debris Removal – NRCS Phase 1-B for Consolidated Gravity Drainage District No. 1 of Tangipahoa Parish"** will be received by the President & Board of Commissioners of Consolidated Gravity Drainage District No. 1 of Tangipahoa Parish at the Consolidated Gravity Drainage District #1 district office Meeting Room, 48571 Highway 51 North; Tickfaw, LA 70466, until **10:30 a.m. (CST) Thursday, March 24, 2022**, at which time the Bids received will be publicly opened and read. The Project consists of:

Removal of obstructing fallen trees and debris resulting from Hurricane Ida by chipping and/or hauling off on about 52.9 miles of designated laterals including W3 (Main) - "Selsers Creek (including South Slough)"; W4 (Main) - "Big Branch"; W6-L1 - "Sims Creek"; W6-L4 - "Washley Creek"; W6-L7 - "Washley Creek"; W7 (Main) - "Bedico Creek", and W9-L10 - "Still Branch".

Construction Budget: \$6.8 million

Contract Term: 195 calendar days

Bids will be received for a single prime Contract. Bids shall be on a unit price basis as indicated in the Bid Form.
