## TOURNAMENT RULES

- 1. Tournament is open to all adult members of the Appomattox River USBC who have reached the age of 50 years as of date of the tournament. All bowlers must be members of the ARUSBC for the current season.
- 2. The tournament shall be a Handicap Singles Event. Entry Fee is \$40.00 All entrants will bowl three (3) games on one pair of lanes. Entries received after January 4, the Entry Fee will be \$50.00. There is an optional scratch event for an additional \$10.00.
- 3. Handicap will be based on 90% of 220.
- 4. Averages: Entrants shall use their USBC Composite League Average, for the 2022-2023 bowling season, as shown on the USBC web site, <u>www.bowl.com</u>
- 5. There will be a separate Women and Men Divisions. Division will be combined if there are less than nine (9) entries in a division.
- 6. If equipment failure on a pair of lanes would delay the progress, the tournament manager may authorize moving participants to another pair of lanes. Participants will be granted a 2-ball practice on each lane prior to the resuming game progress.
- 7. USBC Certified Tournament Rules shall be used to operate this tournament. Should there be any disputes, complaints or protest, the decision of the tournament manager shall be final, except when an appeal is made in writing to the ARUSBC Board of Directors.
- 8. The Prize money shall be returned 100%. The distribution ratio shall be 1 prize for every 5 entries, or major fraction thereof. Prize checks will be mailed or hand-delivered to winners and should be cashed within 90 days of pay-out.
- 9. All brackets and side pots will be exclusively run by ARUSBC.
- 10. Shirts or blouses must have sleeves, no midriff showing and no obscene wording. Trousers, skirts or shorts must come at least halfway to the knee with no rips or holes. Tournament Management will have final say as to proper attire. Bowlers will NOT be permitted to participate until dressed in proper attire.
- 11. Once submitted and accepted, entry fees are not refundable. RETURNED CHECKS FEE IS \$25.00 PLUS BANK FEES. ENTRY FEE CHECKS SHOULD BE MADE PAYABLE TO Appomattox River USBC.
- 12. Premature termination of the tournament brought on by war, national emergency or emergency causes relating from fire, national disaster or any other reason beyond the control of the ARUSBC, will result in entry fees to be returned.
- 13. Tournament must have a minimal of 5 entries to be held, otherwise the tournament will be cancelled and all money refunded.
