

SUMMARY ANNUAL REPORT FOR  
LOCAL UNION NO. 9, IBEW  
AND OUTSIDE CONTRACTORS  
SUPPLEMENTAL UNEMPLOYMENT BENEFIT PLAN

This is a summary of the annual report for Local Union No. 9, IBEW and Outside Contractors Supplemental Unemployment Benefit Plan, EIN 32-0320610 Plan No. 501, for the year ended October 31, 2017. The annual report has been filed with the Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan was \$3,038,973 as of October 31, 2017, compared to \$3,191,265 as of November 1, 2016. During the plan year, the plan experienced a decrease in its net assets of \$152,292. This decrease included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets acquired during the year. During the plan year, the plan had total income of \$65,768. This income included earnings from investments of \$65,768. Plan expenses were \$218,060. These expenses included \$100,215 in administrative expenses and \$117,845 in benefits paid to or on behalf of participants and beneficiaries.

- assets held for investment;
- transactions in excess of 5 percent of plan assets; and

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
