Homecoming Tailgate Party: Elaine reported that the Homecoming Tailgate Party was a success. T-shirts were made and sold and light snacks were provided. After reimbursement of the T-shirt and food costs between T-shirts sales and donations there was \$5.05 in excess which was given to the general fund. There are still T-shirts available for sale and the money collected will be deposited into the general fund. Jayne questioned why a check from the association was not requested for this event and Sharon replied that due to the short timeline it was felt we had to move quickly and it was decided to proceed with out of pocket and reimbursement from the T-shirt sales.

**See's Candies Fundraising**: Elaine also reported that the feeling was not to hold another drive at this time to raise money for the General Fund due to the current Thanksgiving Drive underway and that the scholarship drive will begin in January and it was felt we were asking too much of the Alumni.

**Thanksgiving Donation Drive:** It was discussed that due to the higher price of groceries at Price Rite, this year the alumni should purchase gift certificates for the Thanksgiving Drive to Aldi's. Jayne replied that it has always been Price Rite.

Sharon said we should vote on this. A vote was taken and the majority voted to purchase Aldi's gift certificates in \$100.00 increments

**All Class Reunion:** This will be revisited at the beginning of the new year by James Clements, and it is hoped that holding a reunion will recruit more Alumni members to join.

**Scholarship Drive:** Oscar Perez asked how the scholarship drive works, and it was explained. Darlene Price reported that the Class of 1974 raised money for a Class of 1974 scholarship and that the Alumni could count on a scholarship as such. Elaine reported that the Class of 1974 was shy a couple of dollars to reach \$1,500.00 and would be soliciting the class for more donations.
