

Exhibitors: Participation Requirements: Each exhibitor must have a California resale permit available for inspection and is responsible for collection of sales tax. Each exhibitor must bring/arrange for his/her own interior display props such as signs, tables, chairs, etc. Advanced reservations required. This is a family-friendly event. Arts and Crafts must be appropriate family viewing. CPIA and Main Street Canoga Park reserves the right with respect to presentation, participants and sales not permitted at Día including rights to shut down on the day of the event those not in compliance with Día rules & regulations. No refunds will be given. Drug-related products are prohibited. Alcoholic beverages are prohibited in booths and attractions. Food or beverages may not be sold or served in booths unless you are a designated food vendor.

Indemnification Release and Waiver of Liability: By its signature the Vendor/Exhibitor assumes all responsibilities for the sales of its products, materials and/or services and the actions by any of its employees or agents occurring immediately before during or after Día. By its signature Vendor/Exhibitor agrees to indemnify, defend, save and hold harmless Canoga Park Improvement Association, Main Street Canoga Park and Día de los Muertos and their officers, Directors, Members, agents, employees and Representatives, Bureau of Street Services, Department of Transportation, County of Los Angeles, and the City of Los Angeles and any officers, agents or employees from any claims for damages of any nature whatsoever including, but not limited to, death, personal injury, or property damage arising from or connected to directly or indirectly, its operations, equipment, products, services, as may occur immediately before, during or after the 2019 Día de los Muertos Festival.

Registration Fee, Clean-Up Deposit, and Cancellation Policy: The amount charged for space includes a non-refundable-registration fee of \$25.00. Please help keep our community clean! We are requesting and requiring all participating Vendor/Exhibitor to clean and sweep their areas before they leave for the day and remove all booth related trash to provided large dumpsters. If Día is cancelled in total or part of any reason/cause by the 2019 Día de los Muertos Festival, Canoga Park Improvement Association, Main Street Canoga Park, Bureau of Street Services, Department of Transportation, County of Los Angeles, and the City of Los Angeles, the Vendor/Exhibitor shall not be entitled to any refund. Please note the 2019 Día de los Muertos has not scheduled "rain date" or postponement date." The event will take place in the case of rain.
