

**ROY MUNICIPAL COURT
DEFERRED FINDING OPTION**

A deferred finding is an opportunity to keep a violation off your driving record. It is allowed for one moving and one non-moving infraction once every 7 years. You may request this in writing or at your mitigation or contested hearing. When a deferred finding is entered the infraction will be dismissed if you comply with the following conditions:

1. Have no violations for a period of time that is determined by the Judge.
2. Pay administrative costs assessed, which is normally the amount of the ticket.
3. Attend traffic safety school, if ordered by the Judge

You are NOT eligible for a deferral if:

1. Your ticket is for Passing a School Bus, Speeding in a School or Speeding in a Construction Zone.
2. An accident was involved.
3. You have had a prior deferral in another court in the past 7 years.
4. You possess a CDL (Commercial Driver's License)

If you believe that you qualify for a Deferred Finding and would like the Judge to consider this option, without having to appear in court, please read, sign and mail this statement to the court. Your ticket must be returned with this form if you haven't already requested a hearing. If you qualify, the Judge will sign an order and a copy will be mailed to you. Your deferral period will start from the date the Judge signs the order. Payment is due in full within 15 days from the date the Judge signs the order unless you have requested a time payment. If you are unable to pay within 15 days, a \$10.00 time payment fee will be assessed.

DEFERRED FINDING STATEMENT BY DEFENDANT

1. I agree to pay the required Administrative Fee within fifteen (15) days of the judgment date unless I am requesting a time payment. I understand that by checking the time payment box below, a \$10.00 fee will be assessed in addition to the Administrative Fee.
2. The Court will dismiss my infraction(s) marked DF (deferred finding) at the end of deferral if I pay the Administrative Fee, I do not commit a new traffic infraction or criminal traffic offense at any location within the deferral period being signed by the Judge and attend Traffic School, if required.
3. If I fail to comply with the conditions of the deferral, without further notice to me, a finding of committed will be entered and will be reported to the Department of Licensing.
4. I hereby waive any right I have to a speedy hearing, including the right I have under IRLJ 2.6. I understand that I am entitled to only one deferral for a moving violation and one deferral for a non-moving violation in a seven-year period as defined by WAC 308-104-160. I have not been granted a deferral in the past seven years.
5. I certify or declare under the penalty of perjury under the Laws of the State of Washington that my foregoing statements are true and correct.

TIME PAYMENT REQUEST:

I am unable to pay in full within 15 days and request a time payment to be set by the court.
