PUBLIC HEARING – MILLAGE RATE

1. Public Hearing – The City of Cordele has tentatively adopted a millage rate of 11.060 mills, which is the same millage rate the city has adopted for the past five (5) years. Without this tentative tax increase of 0.001%, the millage rate would be no more than 11.059 mills.

The proposed tax increase, without a rollback, for a homestead property in the city with a fair market value of \$150,000 is approximately \$0.64 per year, the proposed tax increase, without a rollback, for non-homestead property in the city with a fair market value of \$300,000 is \$1.33.
