That includes 206 single-family homes; 62 Villa townhomes; 182 Old Town condos; 28 Creekside units; St. George's Court; the public housing; and apartment complexes.

So, residents are strongly encouraged to purchase their own "No Soliciting" signs to place at their front door to prevent solicitors.



Development of 7601 Cameron Rd.



There is a rezoning request for the property next to the Fire Fighter's Association that is adjacent to homes in the Barcelona Cove cul-de-sac and the homes near the Glenhill Rd. dead end.

CH/CNA was contacted by the Drenner Group, PC to advise us of their plan to file an out-of-cycle Future Land Use Map amendment for 7601 Cameron Rd. The property is currently zoned GR-CO -NP and the Future Land Use Map is Commercial. They would like to propose GR-MU-V-CO-NP with a Future Land Use Map designation of Mixed-Use. They said, "As you probably know, in order to file that application before July we need your permission. We are making this request so that we can develop a residential project on this site that currently only allows for commercial uses. The existing conditional overlay requires a 25' vegetative buffer along the back of the property and we are happy to keep that in place."

CH/CNA has invited their representative to be available at our April meeting to answer any pressing questions and to establish another time to further discuss their vision.



Sign Moved to STOP Downhill Speeding

The City Transportation Department responded to our requests to relocate the speed limit traffic sign closer to Berkman, so drivers are informed of the 30 MPH speed limit BEFORE their vehicles pick up speed traveling down Coronado Hills Dr. The sign is now just past the driveway to the Clifton Center. We appreciate the hard work of our neighbor, Ms. D. S., who was instrumental in getting that done. Warning: If speeding continues, then speed bumps may be installed.

Shared Streets Neighborhood Pop-up

On Saturday, March 19th, the City of Austin Transportation held a "neighborhood pop-up" at the corner of Glenhill Rd. & Shelbourne Dr. to gather feedback and information on how residents would like to improve the safety of our streets. About 15 residents attended and



shared their thoughts using post-it notes and dots. The Public Involvement Specialist, Ms. Camacho (512.978.1651), encouraged residents to contact her regarding questions about the programs or any transportation safety concerns within our neighborhood.
