

AMELIA VILLAGE, OHIO

Ordinance: O-2013-52

AN ORDINANCE ADOPTING SECTION 31.14, MAYOR'S SPENDING AUTHORITY, OF THE CODIFIED ORDINANCES OF AMELIA VILLAGE, AND DECLARING AN EMERGENCY.

WHEREAS, Village Council desires to provide the Mayor with spending authority up to ten thousand dollars (\$10,000.00) in order to meet the immediate and emergency needs of the Village; and

WHEREAS, Village Council desires to create a new Section 31.14 entitled "Mayor's Spending Authority" of the Amelia Code of Ordinances;

NOW, THEREFORE, be it ordained by the Council of Amelia Village, Clermont County, Ohio, as follows:

SECTION I. That Section 31.14, Mayor's Spending Authority, is hereby adopted as part of the codified ordinances of Amelia Village:

Section 31.14 MAYOR'S SPENDING AUTHORITY

The Mayor, as chief executive officer of Amelia Village, shall have the authority to make purchases from time to time for and on behalf of the various departments of the Village in an amount not to exceed ten thousand dollars (\$10,000.00) for each purchase. Council will be notified by the Mayor of these expenditures within 48 hours of the expenditure. The total amount of expenditures made by the Mayor pursuant to this section shall not exceed fifty thousand dollars (\$50, 000.00) per fiscal year.

SECTION II. This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and general welfare of Amelia Village and its inhabitants. The reason for the emergency is the need to immediately enact these provisions to Code of Ordinances, in order to continue the efficient operation of the Village. Therefore, provided this emergency clause receives the affirmative of two-thirds of all members of Council this Ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise from and after the earliest period allowed by law.

SECTION III. This Amelia Village Council hereby finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code.

RENEE GERBER moved to suspend the rules requiring three readings on three separate dates.


