

## Great Dane Club of Arizona –COVID 19 Rules & Waiver Form

1. If you are sick or have been exposed to someone that is sick in the last 14 days – DO NOT COME! If you have been exposed to COVID-19 at work, we're you provided the proper PPE? If not, DO NOT COME! Participation is at your own risk.
2. These shows will be closed to the general public. Please do not bring extra people beyond who you need to help get dogs in the ring.
3. Armbands will be laid out on the table by your ring. The show superintendent will be mailing all armband numbers to the addresses provided on the entry forms. We recommend that you make sure you know your armband number prior to going to the ring. Under no circumstances are you to touch the steward's book. Catalogs will be available for purchase.
4. Masks will be required in all areas, except your personal set up and vehicle. The only time you may drop your mask is when moving your dog, with the judge's permission. All exhibitors must provide their own masks.
5. Please maintain a 6-foot distance both ringside as well as in the ring at all times.
6. This show will be outdoors, please provide for yourself and your dog(s) accordingly. In past years, the temperatures have greatly varied from one year to the next. It can be very hot, very cold, wet and anything in between at this time of year in Arizona. There is no such thing as too much planning. Please do not plan to leave your car running unattended with the AC on. This is not a solid plan for providing for your animals. We want to avoid accidents, so think about shade, ground cover, battery operated fans, and making sure you can keep airflow through your vehicle.
7. Club Members will be monitoring these rules. You may be questioned if you are not actively showing, please be polite in your responses. We have been working very hard to be able to offer this event and negative attitudes will not be tolerated.
8. There will be hand sanitizers around the ring. Please use them. In addition, the restrooms will be cleaned regularly and thoroughly throughout the weekend.
9. Our regular free coffee and donuts as well as our free Subway luncheon have to be cancelled this year. The venue will be offering a CASH ONLY BBQ luncheon on Saturday and there is a form included to order a boxed lunch on Sunday. No other food should be on the premises.
10. Please respect the directions and space of the judge and steward. If you need something inside the ring, ask.
11. Use the designated in and out gates to minimize contact with others
12. Every person entering the show site will be required to provide a signed waiver indicating that they are healthy, acknowledge the risks in participating, and commit to follow the rules and instructions set forth by the Club. This waiver will be sent with your confirmation of entry.

Please make yourself aware of the rules, give yourself plenty of time to adjust to the changes and most of all, have fun!

### NOTICE: ANYONE WHO ATTENDS THESE EVENTS MUST SIGN WAIVER FOR ENTRANCE TO THE SHOW SITE – NO EXCEPTIONS

I fully attest to the best of my knowledge that I do not have COVID-19 at the time of attending this event. I also attest that I have NOT been in contact with or exposed to any known carrier of COVID-19 within the past 14 days. And if exposed to COVID-19 at work, I was provided and wore proper PPE. I agree that I am attending these dog show events entirely at my own risk and take full responsibility for my own health and safety during these events. I will follow all American Kennel Club (AKC), BCOA, OCBC clubs' rules, requirements, procedures, protocols and guidelines to reduce any exposure and possibility of contacting or spreading the virus. I will follow CDC, Federal, State of Arizona and local County/Town guidelines regarding COVID-19.

I fully submit that the AKC and the Great Dane Club of AZ, site control, all other contracted staff, Arizona Golf Resort and any workers or volunteers, are in no way liable for any present or future COVID-19 exposure incurred at any time by any person, in attendance or not in attendance, during or after these events, and hereby waive all rights to file a lawsuit against the above if I am exposed to COVID-19
