### **NEW BUSINESS**

Phil Bures reported the following new business:

- A. Pool
  - 1. Has been drained
  - 2. Overall had a satisfactory season.
  - 3. Will need some minor repairs before next season from wear and tear and chemicals.
- B. Fall Sports
  - 1. Tackle football
  - 2. Cheer- Numbers are the same if not more than previous years. Some complaints and concerns were made known about there being no adult at practice(s). Phil advised it is not a liability issue but it is a concern to some parents leaving children without adult supervision. Also, will consider a change in sign up dates in the future.
  - 3. Volleyball- Starts the Monday proceeding meeting. Numbers are the consistent with previous years.
  - 4. Flag football- Numbers are up from previous years. 36, 1<sup>st</sup>-2<sup>nd</sup> graders. 14, 3<sup>rd</sup>-4<sup>th</sup> graders.
  - 5. Future Footballers- Numbers are down. But is to be expected as the 4 year old age group has been discontinued. Currently 5 years-Kindergartens only.
- C. Fitness Classes
  - 1. Spin- Mornings with Stacey Bures. Evening
  - 2. Yoga- 4 nights a week
  - 3. Core and Cardio- will resume classes after the first of the year.
