## PLAYGROUND CUSHION

Michael reported that he looked into rubber cushion to replace the current kiddie cushion mulch and the cost was much higher. Jon motioned to approve the bid from McKenna; Michael seconded and the motion passed.

# POOL OPENING - COVID-19 DELAY

Due to the pandemic the pool opening has been delayed. Sweetwater Pools (SWP) is prepared to open the pool on June  $6^{th}$  at 25% occupancy, governor's order, with several guidelines. The Board requested that Kristin speak to SWP about allowing the use of pool furniture for the residents and not taking 30 minute breaks to clean, every 2 hours.



A COVID-19 waiver will be required for pool access. Kristin will compile a running list of those that have submitted the waiver. The Board will also allow residents to present the signed waiver to the guards upon admission and the guards will also have blank waivers on hand.

## LIGHTING

Two bids were presented from GreenScape;

- Install solar power lights inside of the perimeter columns for \$8,050.24
- Install lighting under the Live Oaks in the park for \$9,278.57

Michael motioned to approve both of the bids from GreenScape; John seconded and the motion passed.
