- Training Committee

Tech Rescue Training was voted and approved at the Homeland meeting.

Received \$243,200 for training members of D-7 to the Technician Level. Originally proposed over \$400,000.00 and the request were cut in half.

Chief Bemis recently received a quote from DFS to deliver the training. The committee will meet on Monday 10/28. Costs are reasonable and DFS is trying their best to keep costs down. Chief Bemis pointed out that other teams have failed to get together collectively and become part of a unified/collective team. Chief Bemis gave an overview of what is going on with the statewide meetings for tech rescue. That committee is still meeting and is the very early stages.

Chairman advised all Chief's that if they have an interest in tech rescue they need to contact Chief Bemis ASAP.

The Committee will consist of five members. The Chairman has selected Chief Martel and Deputy Chief Normandin; looking for three more members. They do not need to be a chief officer. Looking for those with extensive knowledge in EMS.

Communications Operators - Dave Clemmons to present a program for our consideration This program would be a training program for those interested in operating the District Comm Units.

Discussion of realignment of Strike Team areas;

Options are to move Spencer to Central, Webster to Central, or eliminate Central. Due to the complexity of the issue a special meeting of the E-Board will be scheduled in late November to discuss our options.

Meeting with D-8 & D-14 Discussed meeting with D-8, very good meeting, want to work more together. They are also looking for joint training sessions. Discussion on D-7 Strike Teams responding to D-8.

Vote to allow Strike Teams to respond out of District. A concern was raised about liability. Most if not all D-8 Towns have signed the state 59A agreement. This alleviates the liability. Current vote of the district only allows in district response.
