MINUTES OF REGULAR SESSION OF COUNCIL June 17, 2021

Regular session of Borough Council convened at 7:30 pm. Present were Councilors Tim Sloss, Mike Matlos, Janice Matyasovsky, Christopher Gretz, Elizabeth Lape, Jennifer McClelland and Michael Zrenchak, Mayor Larry Sikorski, Solicitor Matt Racunas and Engineer Laura Branthoover.

Mr. Zrenchak explained that the adoption of Resolution 2021-3 extending thanks and appreciation to Chief Riley will be moved to the July meeting due to a miscommunication. We did not have a chance to call him to have him come tonight.

PUBLIC COMMENT:

Aly Zombek – 2801 B Street: She had 2 requests: She asked if she could post signs for a vendor show in Irwin to draw people from this area to the show. There were no objections to her posting the signs. Mrs. McClelland asked her to please pick them up when to show was over. Her other request – she lives on the corner of Roberts and B Streets. She has told people many times to slow down and stop at the stop sign. She was wondering if the borough could put a stop sign coming down Roberts at B Street rather than having the one just at B Street crossing Roberts. She said that people fly up the hill from A Street as well as down. Mr. Racunas stated that it would require at least a traffic study. There is a process to justify putting in a stop sign. Mr. Zrenchak said that in the mean time, he asked Lt. Caito to have the officers keep an eye on that area. He also said that the borough will look into it and see what is involved and get an answer for her.

Vicki Underwood asked if she could post signs for the preschool at the Methodist Church. Mr. Zrenchak stated that as long as she takes the signs down there would be no problem. He asked council and there were no objections.

Rodney Naccarato – 823 Elizabeth Street: He has come to many meetings with concerns about his property. He stated that he was away recently and when he came back he saw that some of the vegetation was removed from his hill by the borough. Mr. Zrenchak assured him that the borough has not touched it. He stated that he was at the fire hall for a graduation party the previous Sunday and he looked at the hill and it had not been touched. Mr. Zrenchak said that the Street Department has been instructed not the cut the hillside so as to not cause an issue. Mr. Sloss had pictures he asked Mr. Naccarato to look at. Mr. Naccarato confirmed that it was his hillside in the pictures. Mr. Naccarato stated that he owns 3 lots (150 feet). There was discussion of what part of the hillside belongs to him. Mr. Zrenchak asked him what the ultimate solution he wants would be. Mr. Naccarato stated that he wanted it piped, covered up and then put cement slabs down to keep it from sliding down. He just wants something to prevent his land from sliding down into the trench. Mr. Zrenchak asked for a meeting on site to go over pricing to see what this is going to cost. Mr. Racunas asked whose property the

drain was on. Mr. Zrenchak explained the issue to him. Mrs. McClelland stated that the problem started after the flooding at the Fire Hall and Mr. Naccarato confirmed that.

Mr. Zrenchak expressed thanks to Lt. Caito and Officer Mayernik, Fire Chief Corey Derr, the fire department and Mike Matlos for going out the other day when the storms came through. Everyone was right on it. He thanked everyone very much for all their efforts. It was really appreciated. No one was injured thankfully.

PROPERTY: Elizabeth Lape, Chairman, reporting.

She had some good news regarding the school. The borough received another \$45,000 grant through the Blight Remediation Program which we applied for almost a year ago. This brings the total to almost \$200,000. The borough is going to look into starting progressively with the asbestos remediation and as we get more money see where to go from there. A woman in attendance asked if there was anything worth saving in the school because she had gone to that school. Mr. Zrenchak stated that, at this point, no. They can put in the demolition contract that if there is a cornerstone or marker that it would be saved to mark the site of the Liberty school. Mrs. Lape mentioned about the bricks being saved.

He can still take them to the magistrate if it gets bad enough. It gives him the capability to address things that right now he can't and make things better for the borough.

The only thing she has tonight is the South Allegheny Football Boosters Sponsorship that was just received today. The deadline is after the July meeting. She is in favor of it but believes council needs to meet to decide at what amount for the sponsorship. She suggested to talk about it at the next caucus meeting and vote on it next month.

STREETS AND SEWERS: Mike Zrenchak and Tim Sloss, Chairmen

We are moving forward with the pump station project. He reached out to WC Wyle to work on getting a number to get that project moving forward. Last Friday we had the wet well at the existing cleaned. Just to keep everyone informed, they did have a problem with one of the floats and used the last of the floats to repair it. He will put together a list for the July meeting. We are going to have to order parts to keep in stock for the pump station in case of emergency.

Mr. Zrenchak reported that our contract with PA Municipal Services for sewage collection has expired. We are looking at a couple different options to either renew with them or go with someone else. They are also going to look into the feasibility of going to monthly instead of quarterly billing. Also, if we have residents who are behind due to covid or losing their jobs, we want to look into payment plans to try to help them out. The B Street Project for which we received a grant is 95% completed. We just need a guide rail and some punch list items.
