Discuss and possible action regarding Ordinance 2-25-2016-1, granting authority for the execution of a waste services contract with Tiger Sanitation, Inc. requiring the use of Tiger Sanitation, Inc. for solid waste disposal within Elmendorf city limits; providing criminal penalties for non-compliance; providing for the repeal of conflicting ordinances; providing for severability and an effective date; and authorizing shut off of water service for failure to pay solid waste charges.
2. Receive and discuss with possible action a water rate analysis from Communities Unlimited, presented by Mr. Raul Gonzalez. The purpose of the water rate analysis is to determine future water rates due to the increase in cost of water from SAWS.
3. Discuss and possible action regarding Ordinance 2-25-2016-2, superseding ordinance 10-8-2015-1, providing for the assessment and collection of fees and rates for utility services within the city; setting the relationship between the City and utility customers; providing regulations for the management of the City utility systems; providing the pro rata charges for extension of water utility services; providing a penalty for violations of this ordinance; providing a severability clause; providing for the repeal of conflicting ordinances; providing for publication and providing an effective date.
