ALL Vendors agree to ALL the following: ANY QUESTIONS, PLEASE CONTACT US!!!

1. (a). Vendor (on site) SET UP/MOVE IN: Thursday, November 7, 2019 after 12:00 pm (if permitted) or **BY 7:00 am** Friday November 8, 2019. YOU MUST BE CHECKED IN PRIOR to set up BY A TGFYS OFFICIAL!! You will be notified 1 week prior to event, WHERE the OFFICIAL Check-In locations are!!!!
(b). Vendor Teardown/Move Out: BY 6:00 pm Sunday November 10th, 2019 ALL items must be removed. **TAKE YOUR TRASH! RE: boxes, broken items are NOT to be left for US to remove AT ANY TIME DURING THE 3 DAYS !!!!** (Please see details on Unloading & Loading Thank YOU!)
2. The event will take place rain or shine and there will be NO REFUNDS!
3. No subletting of space without prior written permission from TGFYS. (ALL Vendors)
4. Security of the items in the space provided to you, is not the responsibility of TGFYS, the organizers, sponsors or volunteers. **No motorized vehicles are allowed in sale areas after 8:00 am or before 4:00 pm on sale days. NO EXCEPTIONS!!! Unless otherwise noted officially.** No power will be supplied by TGFYS, (on site). If you are going to use a generator TGFYS must be notified IN ADVANCE, locations may/are determined, removal may be required if no previous written notice.
5. Displays/ Handouts are limited to your immediate vendor space unless otherwise approved. At no time will items/clothing display the official TGFYS name or logo unless IT IS an official event product approved ONLY by TGFYS. Copyright & Trademark laws apply.
6. Vendors are responsible for the cost of any items/materials they require for setup.
7. All persons associated with your space may require TGFYS access arm bands to gain access into the sale area during off hours. This is for security & safety. Armbands are received at Check in only.
8. The TGFYS Official EVENT will have the Official Organizer available before & during the event, & will be traveling the route during sale hours. This is normally the same TGFYS contact before the event.
9. Space assignments in/at locations will be at organizers discretion. Day of sale space availability will be determined on Friday at 7:00 am & Saturday at 7:00 am. Same FEE applies!
10. Vendor agrees to allow TGFYS and its partners to utilize their name, products, pictures and/or services in advertising, promotional materials, website unless exclusion is specifically requested in writing.
11. Exhibitor/vendor hereby releases TGFYS, ESE LLC and its agents, partners, affiliates, sponsors from any claim for loss, damage and/or injury to property and/or person(s) in conjunction with their participation in the TGFYS. All Persons are considered "vendors" that have a space at TGFYS.
12. Any damage to a property/building and/or facilities sale site must be reported and paid for promptly by the responsible party and /or assigned vendor and/or vendor's staff.
13. **ALL Vendor vehicle(s) MUST be parked in the designated vendor parking** area during the event. This is to facilitate customer parking close to the sale areas. NO EXCEPTIONS !!!
14. All areas must be left in orderly and clean condition. Dispose of your own trash/ food litter in proper receptacles. NO vendors BROKEN ITEMS, BOXES, JUNK ECT..are to be left in/near event trash receptacles!! Take YOUR stuff with you! Let's keep the fees down, please! Or additional fee WILL apply!

We will ask vendors to re-adjust **only ONCE!** TGFYS has the right to ask you to leave immediately, if for any reason others feel threatened, for obscene comments and the like.
