## PUBLIC CONSULTATION HELD 18<sup>TH</sup> JANUARY 2020

DG said that 25 people attended the Public Consultation. Though the numbers were modest; the participants were well engaged. He has collated their feedback. The recent climate emergencies have provided a good excuse to be very determined in The Plan in relation to development. HB suggested that the opinions of focus groups could be compared. DG agreed that this would prove interesting as a lead up to the six week consultation. LW said there were many different ways to engage with the community. HB said that issues not important a few years ago were extremely important now.

#### DRAFT PLAN UPDATE

DG said that the Neighbourhood Plan is not about community aspirations; but about setting deliverable policy. He is aware of the history of the town and expressed a wish to walk round Mirfield from a conservation point of view. A local Historian Frances Stott has produced a History Trail which is available from St Mary's.
