New York State Fair Welcomes the End of Summer

COVID Tests Distributed

Since the beginning of the pandemic, Assemblyman Magnarelli and the office members have been disbursing hand sanitizer, masks and COVID tests to non-profit organizations in the community. In the last month, the office distributed an additional 1,000 COVID test kits. A mobile unit to help children and families affected by violence has been established by McMahon Ryan Child Advocacy Center, the District Attorney's Office and Street Addiction Institute, Inc. -SAII. Assemblyman Magnarelli secured more than \$50,000 to create this mobile unit which will be used to engage with local children and families who witnessed violence near their homes.
