This agreement shall be effective on the date Outfitter receives Client's deposit and agreement is signed and returned to Hooker mountain. The parties (Outfitter and Client), in consideration of mutual promises contained herein, now agree as follows:

**1. The Outfitter Agrees to:**

- A. Be insured, bonded and licensed/permitted as required by all appropriate State and Federal regulation, wildlife management and land management authorities, including but not limited to Division of Professions and Occupations (DPO), Office of Outfitter Registration; Bureau of Land Management; Colorado Division of Wildlife and/or the U.S. Forest Service.
- B. Provide client with a **(Semi-guided Hunt)**.
- C. Which includes: Access to private land parcels located in area(s) **441 and 214**
- D. Transportation, lodging, meals, clothing, ATV'S: **None Provided**
- E. Hooker Mountain guides will instruct client on hunting area boundaries and meeting places.
- F. **Field dressing animal:** Hooker Mountain Outfitters will assist you in field dressing your animal.
- G. Hooker Mountain Outfitters (**is not**) responsible for obtaining licenses, fee's, taxidermist fees, meat processing, client is responsible for the meat, cape and antlers

The parties understand that the hunting trip may change for reasons beyond Hooker Mountain Outfitters control which includes but not limited to, extreme weather conditions, fire, governmental action, staff illness or other factors beyond Hooker Mountain Outfitters control.

**2. The Client Agrees to:**

- A. Pay all fees when due and furnish all required information by the dates promised and abide by all State laws and regulations, client agrees to abide by rules set forth by Hooker Mountain Outfitters
- B. Purchase applicable license(s) or tags

Outfitters License Number 1465 · Proof of Bond and Insurance provided upon request

- C. Arrange for his/her own travel to and from hunting site
- D. Bring their own personal gear and required safety clothing
- E. If born after January 1, 1949, have in possession a Hunter Safety Card.
- F. Refrain from consuming any alcoholic beverages until all firearms are unloaded and stored for the day
- G. Read and Sign rules set by Hooker Mountain Outfitters and it's Access Agreement, waiver

**3. Fees and Conditions**

- A. A deposit of **50% of cost of hunt per person** which shall be paid by the client to the Outfitter along with a **BOOKING FORM and A SIGNED COPY OF THIS AGREEMENT/WAIVER** at time of booking or this contract will be null and void and in no way binding on the Outfitter unless accepted by outfitter at his sole discretion.
- B. The balance of the fee shall be paid by time of hunt

**4. Cancellations and Refunds**

- A. The deposit shall be held by the Outfitter for and on behalf of the Client and applied against the total fee.
- B. Deposits are non-refundable.**
- C. In the event, the Client does not draw the required license or tag the deposit shall be returned within 30 days of proof that the client did not draw a tag
- D. In the event the Client materially defaults in the performance of any portion of any of his obligations herein, Client's right to participate further may be terminated at the sole option of the Outfitter. Under such circumstances, the Client shall not be entitled to a refund.
- E. Each Client understands that notwithstanding any other provisions of this contract the Outfitter may, at his sole discretion, return any fees paid and decline to accept Client for any reason.

- 5. **Regulatory Information:** pursuant to section 12-55.5-105(l)(c) and (1)(d), C.R.S, Outfitters are bonded and required to possess the minimum level of liability insurance and the activities of outfitters are regulated by the Director of Division of Professions and Occupations in the Department of Regulatory Agencies (DORA)
- 6. Proof of bond and insurance is available upon request
