Henth Stocks stated that he had stayed with his girlfriend, Jan, from Thursday 1.16.97, until about 3:00 pm, 1.17.97. Stocks stated he left Arkadelphia about 3:00pm & returned to his house in Lonoke about 4:30 pm.

He stated that when he got home, he found a note on the kitchen table that had been written to him by his mother. The note told him that his grandparents wanted him to ~~go~~<sup>go</sup> out to eat with some other relatives that evening, & that he should call them.

Stocks stated that he left his house & got over to his grandmother's house in Furlow at about 5:30 pm.

He stated that he went with his grandparents & his aunt & uncle to eat at the Western Sizzlin Restaurant in Jacksonville. He stated that they all rode in the same vehicle, & that they left Furlow at approximately 5:30 pm. He stated that they arrived at the Western Sizzlin at approximately 6:00 pm, & that they were at the restaurant until 7:30 - 7:45 pm.

Stocks stated that they left the restaurant & went to the Wal-Mart in Jacksonville, where his grandfather went inside to purchase a part for a heater. Stocks stated that they were at the Wal-Mart for approximately 15-20 min before they all returned to the grandparents house in Furlow. Stocks stated that he was at his grandmother's a short time, approximately 10 minutes, before leaving & driving to the Edge Club in Little Rock. Stocks stated that he left his grandmother & arrived at the club at approximately 000205

9:00 pm. He stated that he went to the club to see his girlfriend JAN, who had told him ~~that~~ <sup>that</sup> she might go to the club that evening. STOCKS stated he couldn't get into the club, & that he didn't see JAN'S car on the parking lot, so he left the club & drove to ARKadelphia. He stated that it may have been 9:30 pm when he got to the club, & that it may have been at 10:00 pm when he left Little Rock to go to ARKadelphia.

STOCKS stated that he arrived in ARKadelphia at approximately 11:30 pm. He stated that he drove around town for a while, bought a drink, some SKOOL, & got some gas. He stated that he went to the Whispering Oaks Apartments at Henderson State University just past midnight. He stated that he entered the apartment ~~through~~ through a security gate by following another vehicle into the complex.

Stocks stated he went to Kelli Cunninghams apartment, & stayed with her until the police woke him up this morning.

Stocks was asked about valuables in the residence, & he stated that his dad kept cash in the safe, & had upto \$10,000 cash in the safe at one time. He stated that the combination to the safe was kept on a card that was hidden in the "S" encyclopedia of the encyclopedia set in the family room.

He also stated that Neather had a lot of jewelry that she kept in a jewelry box.

Stocks stated that there were several guns & knives that were kept in a gun cabinet at the residence. He stated that there was a 38 caliber revolver, a muzzle loading pistol, & a .45 caliber

automatic pistol that were kept unloaded, in the gun cabinet. He stated that his father didn't allow loaded guns in the house.

Stocks was asked about his relationship with the other family members & he stated that he & his dad had problems in the past, but they had been getting along real good in the last few weeks.

He stated that he & his mother always got along real good. He said that she was always the person who kept everybody together. When Stocks spoke about Henther, he stated that they were very close. He stated that she was very smart, & that he was proud of her because of everything she had accomplished, that he was never able to do.

Stocks was asked about what should happen to the person that had murdered his family. He paused for a few seconds, and then he stated that the 000208
