Ram Tap Horse Park in Fresno, California, has been in operation since 1957. It's situated on approximately 140 acres along the San Joaquin River adjacent to a PG&E substation, gun range, and railroad tracks. There are 13 portable barns with 260 stalls available. There are two multi-purpose arenas or eight dressage rings. The cross-country obstacles can be used as marathon hazards, and there are water obstacles! Lots of room to condition your equine, both flat and hilly areas.

Directions: From SR 99, take the Herndon Avenue Exit 142. Turn right (east) onto Herndon Avenue, cross the railroad tracks at the signal. Turn left (north) about 50' from the signal onto Weber Avenue. Continue through the community for about a 1/2 mile to Ram Tap. HOWEVER, Weber Avenue may be closed for construction. So, continue on Herndon Avenue to Riverside Drive and turn left (north). Go to the first stop sign, Spruce Avenue, and turn left (west). Then, turn right (northwest) onto Van Buren Avenue as it curves left to Weber Avenue. Keep going and you will arrive at Ram Tap!

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

READ THIS AGREEMENT CAREFULLY BEFORE SIGNING IT. YOUR SIGNATURE INDICATES YOU UNDERSTAND IT AND AGREE TO IT'S TERMS. BY SIGNING THIS AGREEMENT, YOU (AND YOUR CHILD) ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE OR RECOVER DAMAGES IN CASE OF INJURY, DEATH, OR PROPERTY DAMAGES, FOR ANY REASON, INCLUDING BUT NOT LIMITED TO, THE NEGLIGENCE OF PG&E, RAM TAP, IT'S OWNER, EMPLOYEES AND AGENTS ("THE RELEASEES").

I, _____ on behalf of myself (and my minor _____ child).Reside at (street, city, zip code) _____

in consideration for allowing me (or my minor child) to handle and ride a horse and on behalf of myself, my child or our personal respresentative, heirs next-of-kin, spouses and assigns, I HEREBY:

Acknowledge that a horse or mule may, without warning or any apparent cause, buck, stumble, trip, roll, fall, rear, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on a person's feet, push or shove a person; saddles or bridles may loosen or break – all of which may cause the rider to fall or be jolted, resulting in serious injury or death.

ACKNOWLEDGE THAT HORSEBACK RIDING IS AN INHERENTLY DANGEROUS ACTIVITY AND INVOLVES RISKS THAT MAY CAUSE SERIOUS INJURY AND IN SOME CASES DEATH, because of the unpredictable nature and irrational behavior of horses, regardless of their training and past performance.

Voluntarily assume the risk and danger of injury or death inherent in the handling or riding of the horse, and use of saddles, bridles, equipment and gear provided by the Releasees.

Release, discharge and promise not to sue the Releasees for any loss, damage, injury (including death) or cost to me or my child's person or property arising out of riding or handling a horse, or use of saddles, bridles, equipment or gear provided by the releasees.

Release the Releasees from any claim that such Releasees were negligent in connection with my or my child's riding a horse, including but not limited to training or selecting horses, maintenance, care, fit or adjusting of saddles or bridges, instruction on riding skills or leading and supervising riders, which resulted in loss, damage, injury or both.

Indemnify, and save and hold harmless the Releasees from and against any loss, liability, damage or cost they may incur arising out of or in any way connected with either my or my child's handling or riding the horse and/or use of any saddles, bridles, equipment or gear provided therewith resulting from or contributed to by my own negligence.

Expressly agree that the foregoing release and assumption of risk, and indemnity agreement is governed by the laws of the State of **CALIFORNIA** and is intended to be as broad and inclusive as is permitted by CALIFORNIA law, and that in the event any portion of this Agreement is determined to be invalid or unenforceable for any reason, the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.

Acknowledge that this document is a contract **for membership at Ram Tap** and agree that if a lawsuit is filed against the Releasees for any injury or damage in breach of this contract, I will pay all attorneys' fees and costs incurred by the Releasees in defending such an action.

IT IS REQUIRED THAT I, MY CHILD AND ALL RIDERS WEAR A PROTECTIVE HELMET.

I have read this document. I understand it is a promise not to sue and to release the facility, it's owners, employees and agents, for all claims. I have made a free and deliberate choice to sign this Release and Waiver as a condition to Releasees allowing me or my child to ride or handle a horse. I have concluded that the risk involved, and the release and waiver of liability is worth the pleasure of horseback riding experience.

Assumption of the Risk and Waiver of Liability: I understand that neither the Brass Oak Driving Society (hereinafter known as "BODS") and/or its officers, event staff, organizers, officials, judges, organizing committee, or property owners, accept any responsibility for accidents, mishaps, damage, injury or illness to persons or horses or property in connection with this event. I hereby agree, without reservation, to be conscious of, be bound by, and comply with the local rules and rules of this event. I am fully aware that horse sports, including driving, are inherently dangerous and there is a risk of serious injury or death. By my involvement I voluntarily and expressly assume any and all risks. I further agree to hold harmless and indemnify BODS, its officers, agents, officials, organizers and property owners for any actions taken, damage, injuries, mishaps or illness. I agree to release BODS, its officers, agents, officials, organizers and property owners from any and all claims including any injury or loss suffered during or in connection with this event. This includes any and all claims for injury, damage or loss, caused by me or my horse, which may take place during or in connection with this competition or event.

I understand it is forbidden to remove the bridle and reins from a horse while hitched to a cart or carriage. _____ (Initial)
