Salute to the Flag / Regular meeting call to order:

Chairman- Jaime Hartline, Vice-Chairman- Raymond Guzic Jr., Supervisor Scott Guzic Solicitor Thomas Swope and Secretary Pamela Flis.

Scott Steberger, Ronald Muldoon and Joshua Beyers representing Mainline Newspapers also attended the meeting.

Public Participation:

Ronald Muldoon-Lilly Mountain Project Plan-update on the reclamation ponds, received correspondence from the Cambria County Conservation District concerning the removed sludge from the ponds 1 & 2, the sludge must be placed on site to dry out, then covered with soil and seeded. Funding is available from the Western Pennsylvania Abandon Mine Collation, contractor to visit the site on 3/2/2017 to inspect the site. Concerns of the entrance to the site, bottom of the road is in bad condition- Reservoir Road- Roadmaster will try to attend to inspect the site and identify parcels of property, so that tree limb trimming may completed. Washington Township Supervisors are willing to assist with the Mr. Muldoon and The Cambria County Conservation District.

Scott Steberger- presented to the Township Supervisors a list of ideas on how to promote the Lilly Borough and Washington Township as a sustainable / environmentally friendly community centered around the landmarks, gathering places, various parks of the community as well as the wilderness and farmlands surrounding Lilly Borough and Washington Township. Beginning with the local girl scouts making bluebird houses, the planned ventures of planting wild flowers, creation of bat boxes, educational walking tours, music venues, a promotion committee, as well as can recycling . Mr. Steberger was asking the Supervisors for their support in his efforts and permission to do so; the Supervisors welcome the enhancements to the walking trails and would like to remain informed on the progress and activities. All planned activities are at no cost to the township and may require some labor and promotional help. Also questions on the operations of the Amfire Coalmine, these questions best addressed to the PA Department of Environmental Protection.

Adjournment:


Motion made by Scott Guzic 2nd Raymond Guzic, Jr. to adjourn the meeting at 6:52 PM. All in favor, Motion passed.
