## State—HCPF/DHS/Alliance/State Legislature

- Department of Health Care Policy and Financing (HCPF)—As part of case management redesign, holding stakeholder meetings. Proposed case management catchment area for our region matches our current area.
- Office of Early Childhood—We have heard that the Office of Early Childhood has received federal \$ for sustainability payments for EI providers, but we don't have details yet.
- Colorado State Legislature—
  - Case Management Redesign Bill flying through process with no real resistance.
  - Bill for state budget in its final stages through legislature and still includes 2.5% rate increases plus over 600 new residential enrollments. CCI is anticipating at least 9 of those.

# Internal CCI highlights

• Family Support issues-Working with Alliance and other CCBs on some of HCPFs new interpretations of the regulations that we find problematic. Using our large surplus to purchase adaptive equipment that will be managed by the Adaptive Sports Association. Will need Board approval for investing about \$100,000 in this equipment.



- *Rate Increases*—In the process of billing for increased Day Habilitation, Supported Employment and Transportation rates and planning to pass along the bulk of the increase to DSPs who have been providing in-person services.
- *Pine Street and Holly House* reopened this month. Option for people to do limited group services, one-on-one or virtual.
