NALA LIAISON REPORT

Top 5 Things I Learned in Tulsa

I had a great time as usual at the NALA annual convention in July. This is such a great networking opportunity and it is invaluable for the liaison to be able to bring back news and ideas to the associations, like RRVPA. This report includes the top 5 things I learned during my week in Tulsa.

- 1. Bomb threats are real. And they are not fun when it's 100 degrees with 80% humidity. Check it out: Bomb Threat Forces Evacuation of Downtown Hotel (http://www.newson6.com/story/29618326/bomb-threat-forces-evacuation-of-downtown-tulsa-hotel). This happened just as we were sitting down for our all convention luncheon (chicken, veggies, rice). The police brought in dogs that went room to room to ensure our safety. I'm thankful the threat turned out to be nothing.... and that our food was edible almost 3 hours later.
- 2. Medical Malpractice is a varied field. It is very important which side you are on defense or prosecution. I took this for my CLE during the convention and learned that this field has its own language and acronyms. I can tell that you would have to be very patient to work in this field... and resourceful. The speaker was the most sought after defense attorney in West Virginia and his former paralegal. They told lots of fun stories to make things interesting!

- 3. NALA is 40 years old! This was very much the theme of the convention. Also, the Executive Director, Marge Dover, retired after 40 years of service to NALA. I learned that 40 years ago, NALA paid Marge a whopping \$9,000 per year and that in the early years, the founding members had to take personal loans to keep NALA afloat until the exam fees began generating income on a more substantial level.
