BOROUGH OF BRADDOCK HILLS MINUTES REGULAR COUNCIL MEETING July 9, 2024

CALL TO ORDER

Thomas Evans President of Council, called to order the regularly scheduled council meeting at 6:59 p.m.

PLEDGE OF ALLEGIANCE

Mr. Evans led the Pledge of Allegiance.

1. CALLING FOR APPROVAL OF MINUTES AS POSTED (all ayes vote)

2. CALLING FOR BIDS

3. COMMENTS FROM CITIZENS (6 minutes each)

Shanel Marshall, 28 Newton Road – Ms. Marschall spoke regarding the conditions of a neighboring house. Mr. Garvin stated that it was a police matter. Ms. Marshall added that the house had no electric and trash issue. Mr. Garvin stated that the building inspector will be contacted and investigate on whether it's a code violation. Ms. Marshall inquired about the possibility of recycling. Mr. Garvin, Ms. Sorrentino and Council explained the difficulty involved including costs and providers.

Carol Palangio, 1051 Ardmore Manor Drive – Ms. Palangio asked Council to review and update the Ordinance regarding parking on Ardmore Manor Drive. She is requesting that street parking be allowed, but for it to a violation to block a driveway and walkways leading from the street. Mr. Garvin stated that the manager and police chief will discuss this matter and make their recommendations for the next meeting.

Mary Pat McDermott, 1098 Brinton Road – Ms. McDermott asked Council to take into consideration some other factors regarding the ban on single-use plastic bags prior to adopting the new Ordinance. She listed several issues with banning these types of bags. Ms. Schaffer asked her for sharing and stated several reasons she is asking Council to adopt the Ordinance.

Ms. McDermott inquired about controlling the deer population and trees on private properties that need maintained. Also, she asked Council to look into having their own email addresses for residents to contact them directly. Lastly, she thanked Council for allowing the residents on McKelvey Road to close the road for their annual block party.

Other discussions during citizens' comments included the condition of Newton Street and a possible nuisance vehicle. Ms. Sorrentino stated that the vehicle is a police matter. She explained the expenses for paving projects and how many grants have requirements that affect potential projects. She stated that they applied for a grant to pave Newton Street, but it was rejected as it didn't meet income requirements.

DeWitt Walton, Allegheny County Councilman – Mr. Walton thanked Mayor Brown and Council for paying attention and listening to their constituents. He explained that budgeting has been an issue for the County and other municipalities since many business buildings have been reassessed, which resulted in lost revenue. The loss in revenue has been an issue since expenses have increased, but revenue has decreased. He stated that this will result in a tax increases. Further discussions regarding this matter followed with Council, Mayor Brown and residents.

Melody Farrin, 2826 McKelvey Road – Ms. Farrin stated that twelve trees have been planted within the Borough as part of the Shade Tree Commission. She added that six trees will be donated for the walking track and playground area. Ms. Bolton stated her issues with trees in the Borough.
