AN ORDINANCE REVISING SEWER RATES FOR THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS

WHEREAS, the Corporate Authorities of the Village of Chapin, Morgan County, Illinois find it to be in the best interests of the Village residents to increase the rates for the use and services of the Village's sewer system.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. Effective June 1, 2016, Paragraph F of Section V of Ordinance 83-14 (sewer rates) is hereby amended by the deleting said paragraph and replacing it with the following new Paragraph F:

F. The sewer use charges shall be billed according to the following schedule of charges. For buildings housing more than one family or sewer customer a separate use charge shall be made for each occupied unit.

SEWER RATES

0 to 2,000 Gallons:

Minimum Charge of \$10.00

Over 2,000 Gallons:

An Additional Charge of \$6.00 per

1,000 gallons

Commencing on May 1, 2017 and on every May 1st thereafter, the sewer charges set forth in this Paragraph F shall be increased by three percent (3%) unless said annual increases are waived by the Corporate Authorities of the Village of Chapin.

SECTION 2. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby superseded to the extent of the conflict.

SECTION 3. This Ordinance shall be effective upon its passage, approval and publication in pamphlet form.
