SPECIAL MEETING ------ January 28, 1981

Meeting was called to order by Chairman Darwin Gilger with the following members present: Neal Dalton, Dan Holyoak and Linda McKinney. Also present: Attorney Harry Snow; Dave Bretzke, Executive Director; and Beulah Croasmun, Assistant Secretary.

Minutes of meeting held January 14, 1981 were read and approved as read.

Dan Holyoak explained that the Board had agreed at an earlier meeting to utilize the services of the City of Moab to perform the maintenance for the District on a job basis. Bretzke reported that the city officials have agreed to do this, but an agreement has not been prepared.

Bretzke reported that Dale Pierson has been hired as maintenance man for the two Districts. Bretzke stated that at a meeting of the Conservancy District and the Special Service District a motion, initiated by George White, was passed authorizing Bretzke to hire the personnel for the District. Bretzke stated that the new man's duties would include reading water meters and obtaining sewer easements. Bretzke reported that approximately 80% of the office staff's time last month was spent doing work for the Spanish Valley District.

Bretzke reported that Kent Vigos from Boettcher & Company visited the office last week and offered the services of his company if the District needs bonding assistance or interim financing.

Bretzke stated that chlorination equipment for the George White Well has been ordered. He said there could possibly be water available by February 16th.

Bretzke reported that Charles Webb and Gerda Stoltz decided they did not want a culinary water connection at this time and have asked that their \$300.00 Plant Investment Fee be refunded. Bretzke also stated that it will be necessary to refund Leroy Walker and Oral Clark's Plant Investment Fee because we were unable to obtain an easement from Harold Nelson to put a line up to their property.

Dan Holyoak moved that \$300.00 each be refunded to the following customers:
