## Missouri Stay-at-home Order Extended To May 3, 2020

On Wednesday April 22, 2020, Governor Mike Parson announced that most businesses would be able to reopen their doors when the state begins to loosen restrictions on movement early next month, until that time, the Governor's statewide "Stay at Home" Order remains in effect. The Order went into effect on April 6, 2020 and has been extended to May 3, 2020. The Order specifically preserves local authority to implement additional requirements in local jurisdictions, as long as they are not inconsistent with the Order. Therefore, because Counties around the State already had similar or more restrictive orders in place, for those Counties, the Governor's Order may not add many additional restrictions. Despite the Governor's hint that the state's businesses would be reopening in May, schools will remain closed.

The Warren County Commission has extended its previous State of Emergency (Order No. 07-2020), which will remain in effect until 11:59pm on April 30, 2020, unless otherwise rescinded or extended further. The full order can be viewed on the Village website.

## **COVID-19 and Animals**

Based on the limited information available to date, the risk of animals spreading COVID-19 to people is considered to be low. We are still learning about this virus, but it appears that it can spread from people to animals in some situations. The first case of an animal testing positive for the virus in the United States was in a tiger that had a respiratory illness at a zoo in New York City. CDC is aware of a small number of pets, including cats and dogs, reported to be infected with the virus that causes COVID-19, mostly after close contact with people with COVID-19. Treat pets as you would other human family members - do not let pets interact with people or animals outside the household. If a person inside the household becomes sick, isolate that person from everyone else, including pets. Further studies are needed to understand if and how different animals could be affected by the virus that causes COVID-19 and the role animals may play in the spread of COVID-19. 
## CDC on Homemade Cloth Face Coverings

CDC recommends wearing cloth face coverings in public settings where other social distancing measures are difficult to maintain (e.g., grocery stores and pharmacies), especially in areas of significant community-based transmission. CDC also advises the use of simple cloth face coverings to slow the spread of the virus and help people who may have the virus and do not know it from transmitting it to others. Cloth face coverings fashioned from household items or made at home from common materials at low cost can be used as an additional, voluntary public health measure.

Cloth face coverings should not be placed on young children under age 2, anyone who has trouble breathing, or is unconscious, incapacitated or otherwise unable to remove the mask without assistance.

The cloth face coverings recommended are not surgical masks or N-95 respirators. Those are critical supplies that must continue to be reserved for healthcare workers and other medical first responders, as recommended by current CDC guidance.


