She said they are discontinuing the 911 Service, as it is not feasible. The Ambulance service was also discussed and Stuart said she is meeting with the City of Bridgeport regarding this matter.

Sarah Paisley, Extension Educator, met with the Board. She had the Interlocal Agreement with Garden County for the vehicle Morrill County had purchased. Metz said he had attended their meeting yesterday. Garden County agreed to pay half of the \$14,000 for the vehicle and to pay for half of the maintenance, gas and repairs.
