





ORDINANCE NO. 23 - 04

AN ORDINANCE VACATING THE ALLEY BETWEEN
LOTS 56, 77 AND 78 OF PICQUETS ADDITION
IN THE CITY OF NEWTON, JASPER COUNTY, ILLINOIS

WHEREAS, WADE COMMUNITY FIRE PROTECTION DISTRICT, has requested that the City of Newton, Jasper County, Illinois, that the City of Newton, vacate a certain Alley; and

WHEREAS, the legal description of the alley to be vacated is described as follows, to-wit:

The alley between Lots 56, 77 & 78 of Picquets Addition from 1st Avenue to the Westerly Right of Way line of the former Illinois Central Gulf Railroad.

WHEREAS, WADE COMMUNITY FIRE PROTECTION DISTRICT is the owner of the land abutting the aforescribed Alley; and

WHEREAS, the Alley which is the subject of this vacation does not contain any public services or public utilities; and

WHEREAS, proper notice of public hearing has been given and a public hearing was held February 7, 2023; and

WHEREAS, it is determined that the public interest will be served by vacating the aforescribed Alley; and

WHEREAS, the aforescribed Alley does not serve any unincorporated area but is wholly located within the city limits of the City of Newton, Jasper County, Illinois, and

WHEREAS, the said Alley is under the jurisdiction of the City of Newton, Jasper County, Illinois.

BE IT ORDAINED by the City Council of the City of Newton, Jasper County, Illinois, the alley between Lots 56, 77 & 78 of Picquets Addition from 1st Avenue to the Westerly Right of Way line of the former Illinois Central Gulf Railroad located in the City of Newton, Jasper County, Illinois be and here by is vacated.

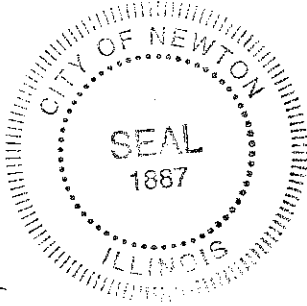


