AIS Update

The BLCA treated offshore [farther than 150 feet from shore] Curlyleaf Pondweed (CLP) AIS April 22nd this year. This is the earliest ever with a DNR cutoff date of April 30th. When this year's date is compared to previous years one gets a little idea of how unusually mild this winter was. Previous treatments: 2013 - 5/23; 2014 - 5/23; 2015 - 5/11.

Lake Management treated personal shoreline for weeds within 150 feet from shore (near shore) June 7th. Late near shore applications and properties requiring DNR inspection prior to treatment were treated June 22nd.

Looking at the treated areas our 2016 application was effective. Unfortunately, cost and DNR guidelines prevent treatment of 100% of the CLP. Right now untreated CLP is blooming and forming mats on the lake surface. These plants will die off soon but have already formed reproductive pods that will form plants up to 7 years from now. By this fall, next year's crop will sprout and grow under the ice all winter. And so it goes.

Until this year's CLP has died off, we will encounter washed up debris from cutup and dying plants along our shoreline. This is already washing up onshore. Removing this waste prevents the nutrients in the plant matter from recharging the lakes and feeding the algae that will come along with warmer and more turbid water. Collected CLP debris can be dropped off at the Becker Compost Center. Jan's Tree Farm will also accept it, if contacted first.

I decided to repurpose the stuff I raked up along my shore. I pitchforked it into piles along shore. After it dried a couple of days, I transferred into a wheelbarrow.

During the transfer I did a weed inventory to check for Eurasian Water Milfoil and shore land plants that would grow out of the lake. (Sometimes my piles were on top of weeds like reed canary grass growing along the lake. Not a good idea to spread this around so I had to be careful I didn't transfer it into the wheelbarrow.) Trash and non-aquatic plants were separated, and then the rest was used as mulch in my garden for weed and water control.

Check out my before and after CLP to my garden photos. I smothered the weeds with what I hope is inert, biodegradable compost.
