#### **VIII Old Business**

- A) **Well Pressure Tank vs other options** Direction was given to contact Longfellow to be done by 2026. Mr. Drake moved to accept Longfellow Excavating bid to tap int o our existing water lines to support the well pressure. Mr. Bolton 2<sup>nd</sup> the motion all in favor.
- B) **Toys for Tots.-** Have insurance locations the board wants up by the VACTE conex box.
- C) **VIP** area for 2025 Arena Staff would like to try a VIP section at the Arena for the 2025 fair there would a sectioned off area with its own security and bartender we will try it for one year and go from there. The original thought is 50 people per night at \$25 per night.
- D) Water Truck update Mrs. Gilboy does not have any way to evaluate the Premier Diesel donation so if someone can go look at the truck we can move this forward. Longfellow Excavating has been making sure we have coverage for all our barrel races and gymkana in case our stops working. Mr. Drake stated he would go look at the potential donation and get back to the board. Other option would be to re-build the rear end of the current truck.

# **IX New Business**

- A) **Livestock Scholarship** There were 6 applicants and the livestock committee is having them evaluated but they recommend to give 3 awards like they did last year in the amounts of \$2,500, \$1,500 and \$1,000 last year they received enough in the purchase of the auction animals and the extra over the t-shirts to cover the scholarship. Mr. Drake moved to accept the Livestock Committee recommendation for the 3 scholarships. Mr. Rice 2<sup>nd</sup> the motion. No more discussion all in favor.
- B) **Insurance** We received our insurance renewal for the 2025-2026 season the cost went up 7%. They did ask for additional companies to bid the policy unfortunately the others would

- not bid the policy to be able to buy insurance for our vendors and the people who rent our buildings. This is a vital part of our policy. Next year the board would like Jonna Randal from Farm Bureau to bid the policy and any other company that supplies insurance to other fairs.
- C) **Parking Lot** Diagonal road we would like to take out the "Grand" avenue that runs from the RV Dump up to the livestock gate can we please remove this road and try to "straighten" out the parking in the parking lot for the 2025 fair season and if it works we will make it more permanent in the future. Board said yes we can make these improvements.
- D) **Commercial Building Floor** we have 2 bids to strip the commercial building floor and then either seal it or stain and seal it. At this time we are going to hold off and look at this another time the cost is a little much at this time.
- E) **New Computers** last month the board gave approval to purchase 2 computers, but staff is now asking to replace all 3 computers the current operating system will become obsolete in October so if we are going to replace 2, we would like to purchase 3 and have them all compatible. Mr. Drake moved to purchase a 3<sup>rd</sup> computer and increase the cost of the 3 computers to \$4,000 total. Mrs. Rench 2<sup>nd</sup> the motion there was no more discussion and all were in favor.
