#### I. Call to Order

#### II. Workshop

# a. Continued Discussion - Ordinances, Processes, Procedure

Aaron Boguen shared with the Board a guidance sheet regarding LD 2003, "An Act To Implement the Recommendations of the Commission To Increase Housing Opportunities in Maine by Studying Zoning and Land Use Restrictions". Aaron believes that with the guidance from this document that there will be less changes needed to the Land Use Ordinances (LUO). (NOTE: The LD 2003 guidance sheet is available in the Planning Board office and by request.)

The Board discussed contacting Southern Maine Planning and Development Commission (SMPDC) to determine if Parsonsfield would be eligible for a grant to assist with the potential changes needed for the LUO. Aaron will check to see who the Board will need to speak to at SMPDC. He is hopeful that other towns have started to work on this and Parsonsfield may be able to work with them on this. The Board asked that this be added as an agenda item for the August 16, 2023 business meeting so that they may discuss the matter further and vote as needed.
