

The Montana Health Care Association, which represents nursing homes, assisted living facilities, critical access hospitals, and personal assistance agencies throughout the state of Montana, created a Foundation to offer nurse scholarships to Montana students in an attempt to help develop a nursing workforce to meet our current and future needs.

The purpose of the Foundation is to create a perpetual scholarship fund through donations and investment income and to award scholarships to deserving nursing students.

Pursuing a career in nursing will undeniably have its challenges. What shouldn't be a challenge is finding the financial resources to help achieve career goals. You can help. Your generous donation now will touch the lives of not only those studying to become nurses but also the patients these nurses will care for in the years to come.

Nursing scholarships . . . helping the students and health care workers of today become the caring nursing professionals of tomorrow.

Each year the Foundation awards several scholarships of up to \$2,500 each under its Donald E. Pizzini Memorial Nurse Scholarship Program. These scholarships are granted to college students from Montana, as well as professionals who are already working in the long-term care field who are interested in pursuing a career in nursing or in advancing in their nursing career—with an emphasis on long term care.

This program memorializes Don Pizzini, a former President of MHCA, and a former Director of the Montana Department of Public Health and Human Services. In his many years as administrator of the

Cascade County Convalescent Center in Great Falls, and in his work with MHCA, he had a passionate commitment to long term care and the elderly and to the dedicated caregivers who worked to give them the quality of life they deserve. These scholarships are awarded in honor of this dedicated, innovative leader.



Applications must be submitted by the last day of February each year. Scholarship winners are determined by the Foundation board of directors. Scholarship funds may only be used by students to pay for tuition, fees, books, supplies, and equipment and is paid directly to the educational institution.

To be considered for a scholarship, applicants must meet specific eligibility criteria, including academic excellence, and must pursue study at an accredited college on a full-time or part-time basis in a nursing program relevant to long term care. Preference is given to those individuals currently working in or demonstrating an interest in pursuing a career in long term care.
