- 1. Fees must accompany entries. Sandia Dog Obedience Club assumes no responsibility for incomplete or inaccurate information on the entry form or for a dog being entered in a class for which it is not eligible.
- 2. Entries must be on a current, official American Kennel Club entry form. Conditional, unsigned, incomplete, telephone, facsimile or emailed entries will not be accepted.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Trial Committee
- 4. Entry fees will be refunded for bitches that come into season after the closing date of the trial. A veterinarian's note is not required. In addition, SDOC will refund 75% of entry fees to dogs that are unable to compete due to injury. In order to receive a refund, the trial secretary must be notified no later than one half hour prior to the start of the first class in the trial, and a note from the dog's veterinarian must be provided for injured dogs.
- All mail must be addressed to the Trial Secretary's address. Priority and Express mail must be sent with a <u>waiver of signature</u> requirements.
