



Unstaffed Hours Access Policy Agreement

Unstaffed hours access:

Monday - Friday 8 pm – 5 am

Saturday 1 pm – Monday 5 am

- Access fee: \$10 per month per person added to membership dues. Monthly membership dues and access fees must be kept current.
- In the event access is revoked a \$10 penalty fee will be charged prior to access to being granted a second time.
- Allow up to 72 hours for access to be approved and granted.
- Access is for weight room and attached restrooms all other areas of the facility will remain locked.
- Unstaffed hours access is available to members age 18 and older only. Guests, Non-Members, and any person under the age of 18 are not permitted.
- Use access key app during unstaffed hours only, during staffed hours use front door entrance and check-in with front desk attendant.
- If you are in the facility at closing you agree to leave and enter the facility using access key app. If you are in the facility at opening you agree to check in with the front desk attendant.
- You agree to ensure the door has securely closed after you enter/exit. Each individual is required to use their access key app. No piggyback entries, (ex: allowing spouse, friend, etc. to enter facility directly behind you without using their access key app) doing so will result in revoked access.
- You agree not to enter facility if your app doesn't unlock the door (contact CCC during staffed hours). Do not follow another individual into the facility or open the door for another individual, doing so will result in revoked access.
- Equipment is to remain inside the facility, no exceptions.
- You agree to inspect equipment for potential risk prior to use.
- You agree to use equipment as it is designed to be used. It is strongly recommended not to bench press without a spotter or using spotter arms.
- You understand that the facility is unstaffed, therefore assistance or medical attention will not be available to you in the event of an accident.
- You understand that if you leave your phone or any items inside the facility they will be locked in and you will not have access to it until staffed hours resume.
- The CCC reserves the right to suspend/terminate membership and/or revoke access at any time.
- By signing you fully understand and agree to abide by all CCC Policies, staff direction, and Code of Conduct.
