Wristbands will be delivered in the next few weeks. Look for a white envelope on your porch. Wristbands are for residents only. You may bring up to 5 guests per residence for \$2/guest.

FGHA BOARD MEETING – March 6, 2024

PPROVED Minutes, Respectfully Submitted, Pam Miller, Secretary

The FGHA Board Meeting was called to order at 7:03PM. Board Members in attendance were Paul McCann – President, Roland Bardony - Parks Director, Christina Saenz – Vice President, Laurel Kent – Social Director, and Steve Stanovcak – Pool Operations.

February 7th Minutes –On a motion duly made and seconded and approved by all Board Members, the February 7th minutes were approved.

Guest Speaker – Danielle Cwirko-Godycki

Danielle is running for City Council for district 4. Although that is not our district, she feels she will be representing all of San Mateo as well as her district and wants to see what some of our top priorities might be for our neighborhood.

Danielle has lived in San Mateo most of her life and decided to get more involved when her home flooded along with 10,000 other homes in San Mateo on January 1st, 2023. She realized that there were a lot of urgent needs in our city, such as infrastructure, housing, and potholes. Some of the issues that were brought up as top priorities in our neighborhood were so many developments going up in our area, so many empty businesses yet there are still more developments going up and traffic in our area. Also, more students will be driven into our neighborhood when Fiesta Gardens becomes College Park.

Danielles feels strongly about listening to the community, that we need affordable housing but done in a more pragmatic way and to make it easier for businesses to come into San Mateo.

Financial /Steve Gross

- February operating expenses \$16,800, \$7,400 went toward legal fees.
- Cash in operating account is \$136,800.
- Cash in reserve and cabana fund account is \$101,000. Cash needed to finish the cabana is \$44,600.
- Dues collected in February, \$72,100. As of the end of February we have collected a total of \$164,600 in dues.
- No assessments were collected in February. 2 Members are making monthly payments and 2 are in collections. Since we started collecting the special assessment in August of 2019 485/489 Members have paid in full. We have collected as of the end of February \$1,368,750.

<u>Vote to Approve New Signers to HOA Checking Account – On a motion duly made and approved by all Board Members, Steve</u> <u>Stanovcak and Paul McCann were approved to be co-signers on our HOA checking account.</u>

Cabana Renovation Update

It would be great if we could promote the buy a brick promotion again. Once people see them the feeling is more residents will want to purchase a brick. April 10th will be our first event and Steve will get a temporary certificate. There are about 12 more items on our punch list. Four final inspections need to be done. Furniture has been ordered for inside, cracks in the floor will be fixed before the new furniture can be put in.

The FGHA Board Meeting was called to order at 7:11PM. Board Members in attendance were Paul McCann – President, Steve Muller - Pool Maintenance, Rich Neve - Civics Director, and Steve Stanovcak – Pool Operations.

March 6th Minutes - On a motion duly made and seconded and approved by all Board Members, the March 6th minutes were approved.

Financial /Vicky Nguyen

- March operating expenses \$22,000. This included furniture for the cabana, pole removal, and legal fees.
- Cash in operating account is \$125,800.
- Cash in reserve and cabana fund account is \$101,000. Cash needed to finish the cabana is \$44,600.
- Dues collected in March, \$10,400. As of the end of March we have collected a total of \$175,000 in dues.
- No assessments were collected in March. Two members are making monthly payments and 2 are in collections. Since we started collecting the special assessment in August of 2019 485/489 Members have paid in full. We have collected as of the end of March \$1,368,750.
- We have sold 111 bricks in total. We will be resuming brick sales and David Martin will again be in charge. The prices have gone up. You can learn about buying a brick to be laid at the new cabana on ManageCasa, The Bee, and a QR code at the pool.
