FINANCE "FACTS & INFORMATION" JANUARY 2017

The following information came to our Dept. <u>after</u> the Fall Conference, otherwise you all would have been informed at that time BUT all Units must heed the word that came to us from National Secretary Dubbie Buckler thru advice of the National Judge Advocate.

The issue deals with the wording "Candidate Fund" or "Campaign Fund". If your Unit or District have such labeling within your documents, PLEASE CHANGE IT TO READ: "LEADERSHIP DEVELOPMENT FUND" and DO NOT IN THE FUTURE establish such funds with the names "Campaign Fund or Candidate Fund".

Reasoning: the IRS has cited an ALA Unit that made a Unit donation to a Legion National campaign fund for making a political contribution. While the Judge Advocate explained that supporting internal ALA/Legion/SAL candidate funds is not an engagement in partisan politics, the IRS has interpreted such support differently, and in a field audit cited an ALA unit for engaging in political activity contrary to our IRS tax exempt classification.

The IRS does not distinguish between campaign activities that are external (partisan political party candidates seeking public office) and internal (ALA members seeking leadership positions within their departments/intermediate bodies/units). The IRS' position is that ALA candidate campaigns constitute "political campaigns". If you are not in compliance with the foregoing information you are jeopardizing the entire ALA non-profit status with the IRS.

I could go on and on about the email from National (I received 5 pages) but what I have written for you all is the gist of those 5 pages, so please heed the warning. Your Department is in the process of correcting some of the wording with our accountants. The Finance Committee gave its unanimous approval to the change of name and ALL MEMBERS OF THE DEPARTMENT EXECUTIVE COMMITTEE have been notified and asked to give their approval to the change. Not all have replied as of the writing of this document.

Christmas Gift Shops will be over when you receive this bulletin – we hope you all were part of this fantastic program. Has your Unit remembered to file their reports with the IRS, the AZ Corporation Commission and the Secretary of State. If you had a change of officer from the original Secretary of State form, you need to notify that agency of the ,change. ALSO DON'T FORGET THE YEAR END FINANCE REPORT TO ME BY <u>MAY 15, 2018.</u>

Bless all of you and keep up the good work on behalf of our veterans, their families and the communities.

We need to protect our veterans' rights!

Hope you have a very Happy and Prosperous New Year!! As the New Year begins veterans are still in need of the American Legion Auxiliary support.

(Please provide this bulletin to your Unit Legislative Chairman)

Thank you to those that submitted a Mid-Year Report. It truly helped in constructing a report to the National Legislative Chairman. Information provided from the reports indicated that your members have been provided direction to the ALAforVeterans.org and legion.org/legislative websites. They are also submitting emails to their Congressmen and attending local Town Hall meetings. It is imperative that we remain diligent keeping our members informed on legislation that affect our veterans and their communities.

Recently an email was sent to your District President regarding signing an e-petition on Senate Bill 2193 Caring for our Veterans Act of 2017; VA's comprehensive caregiver assistance benefits to disabled veterans of all eras. The request was for the District President to sign the e-petition to support Bill 2193 and then to forward the message to their Unit Presidents, who in turn were to forward the information to Unit Membership supporting Bill 2193. I truly hope you and your membership have received the email message and signed the petition. Veterans and their families need your support on this bill. All members can read up on Bill 2193, as well as other legion supported legislative bills, through legion.org/legislative website.

This was not the first time I had sent an email to District Presidents. There were others that linked into The American Legion Legislative Action Center requesting signing letters to your congressmen for Medical Cannabis Research and Legion Opposes Steep TRICARE Fees Hikes. I will continue to send emails to the District Presidents who will in turn forward them on. The letters can be made into a hard copy for your members that do not have email, to sign. Generally there are 3 letters, 2 Senators and 1 Representative. The letters are grouped by the name of the Congressman and mailed directly to that Congressman's DC address; so there will be 3 large envelopes sent. Again, it is imperative that we take action and tell our Congressmen that we support our veterans, active duty military and their families.

In the coming months I encourage you to continue educating your Unit on legislative issues promoted by The American Legion and the importance of attending Town Hall meetings and legislative receptions in their communities; to continue developing relationships with their elected officials.

There might be someone in your own Post who you can quietly help.

Remember : Guidelines have been established to ensure Poppy Fund money is used properly. They are listed in the resolution as follows:

- 1. For the rehabilitation of veterans honorably discharged from the United States Armed Forces after April 6, 1917.
- 2. For the welfare of the families of veterans of the above-named period.
- 3. For the rehabilitation of hospitalized military service personnel returning home and awaiting discharge who require treatment in service hospitals.
- 4. For the welfare of veterans, active-duty military personnel, and the families of veterans and active-duty personnel of the above-named period where financial and medical need is evident.
- 5. For the purchase of poppy kits and supplies used to make symbolic poppies and poppy items that will be distributed for donations to the Poppy Fund.

The Poppy funds can only be used specific for veterans / their immediate family. It can be used for veterans creative arts and other needed programs that are for veterans only. It cannot be used for things like community food banks etc. where the general public collects. Those type of donations must come from other income sources, not poppies.

What can you do?

Ideas: Members and Units

• Crochet hats, scarves or mittens to be distributed to homeless veterans. Use information provided by your department chairman to contact the homeless veteran coordinator at the VA health care system nearest you to explore what the unit or you can do to help homeless veterans in your community.

• Participate in the VA Project CHALENG organized by the VA health care system nearest to you. (Project CHALENG for Veterans enhances the care for homeless veterans provided by your local VA and its surrounding community service agencies.)

• Contact your local post chairman and offer your assistance if requests for help come through the Legion's Family Support Network (FSN).

• Raise funds for local American Legion posts to help veterans and their families through the Family Support Network for veterans at risk of losing their housing or homeless veterans transitioning to permanent housing. o Make payments of overdue rent, utility payments or deposits and security deposits.

• Host or volunteer at homeless veterans' stand downs, events where homeless veterans receive free goods and services such as haircuts and medical exams.

• Contact homeless veteran emergency shelters, transitional housing projects and permanent housing projects in your community and identify the organization's volunteer and in-kind contribution needs, including:

- o Meal preparation and serving
- o Clothes collection and distribution
- o Assembly and delivery of hygiene kits, buddy baskets
- o Purchasing or securing household items or furniture

• Reach out to specific homeless veterans, such as residents of projects mentioned above to provide her/him practical, social and moral support

• Compile "blessing bags" to be given to the local police department or other organizations that deal with the homeless veteran population.

• Create a "Tree of Warmth" by collecting scarves, mittens, hats and attaching them to a tree in a location the homeless frequent. Include a sign that says, "Please Take if Needed," "Free if Needed," or something similar.

VA&R REPORT TUCSON VA MEDICAL CENTER 11-30-17

American Legion Auxiliary Units sponsor Bingo parties which are held on the third Saturday of each month at 1:30PM in Building 60 at the VA hospital. Volunteers are needed to assist with this activity, which is much appreciated by our hospitalized Veterans. Please consider sponsoring the Bingo program. Thank you to the past & current District presidents who volunteered at the June Bingo. We are now welcoming Veteran patients from the Building 95 Substance Use Treatment Disorder Program to our Bingos.

The American Legion Auxiliary Units sponsor Bridging Ceremony refreshments for the Substance Use Disorders Treatment Program (SUDTP) on the third Tuesday of each month and any month that there is a fifth Tuesday. We sponsored refreshments on November 21st, 2017. We will be sponsoring refreshments on December 19th, 2017. Volunteers are needed to help with this program. The time is 2PM and the venue is Building 90 at the VA hospital. Thank you to members of Unit 131 & 132 who have volunteered to help with this program. Special thanks to Fire Woman and Jude for all their assistance with this activity.

The new Residential Mental Health Rehabilitation facility is now open. This added 25 new beds to house Veterans in various treatment programs with on-site housing on the hospital campus. Previously these Veterans were bussed to and from residential shelters. This facility will allow for additional supervision of Veteran patients and it is felt that this will contribute to their success in the program. This facility is requesting clear backpacks (25 per month) and water bottles (25 per month). The staff requesting these donations has put forward that donations in kind, rather than monetary donations, would best fill this need. Units 102, 131, 132, 109 and District 2 have responded to this need and we ordered 250 backpacks and water bottles in July.

Veterans Creative Arts Festival is scheduled for February 7, 2018. Volunteers are needed to assist VA personnel with conducting this event.

The grand total of monetary donations by American Legion Auxiliary Units for May 1, 2017 to October 31, 2017 is \$6,858.13. Thank you Unit 66 for your generous donation.

The grand total of material and activity donations for the American Legion Auxiliary for May 1, 2017 to November 30, 2017 is \$29,499.50. We would like to express special thanks to Elaine Yates and Yuma Unit 19, Ann Reatherford, Unit 24, Unit 131, Unit 132, Unit 73 and Unit 109 members and unaffiliated volunteers for their constant support of VA programs through their donations. The Legion family is the largest supporter of the Arizona Fisher House. Currently, Arizona Fisher House is funded for the foreseeable future. Other programs are in dire need of donations (ie. Homeless, Building 95, Social Services, Bingo, etc.).

Fifteen registered hospital volunteers and ten summer youth volunteers, donated time which was credited to the American Legion Auxiliary. The grand total of registered volunteer hours May 1, 2017 to November 30, 2017 is 3,361; occasional volunteer hours are 84 donated by twenty one occasional volunteers. We are now down to ten registered volunteers at SAVAHCS. Please consider volunteering at SAVAHCS if you can possibly devote the time. We have one new American Legion Auxiliary registered volunteer. Please consider sponsoring a summer youth volunteer at SAVAHCS. The cost is \$40 per youth. All hours logged by each sponsored youth will be credited to the American Legion Auxiliary.

This chairman has volunteered 199 hours and logged 2,400 miles this year in service to the Tucson VA Medical Center as of November 30, 2017.

The will be opening another facility in Gilbert in about 15 months. The current facility has been open about 18 months. The do not treat adolescents and geriatrics. They are working with the VA to help with the current epidemic of suicides.

Roll call was taken, the minutes were approved.

Financial report was givin. Current cash balance is \$52,467.79.

Kansas City Chiefs Hall of Fame, Nick Lowery gave a presentation on his Youth Foundation designed to help youth and veterans. He invited everyone to come to St. Vincent DePaul, 1075 W. Jackson for Christmas.

Lee Huff from Congressman Biggs office discussed the new program dealing with the appeals process. For more information call 602-256-0551.

Dr. Maureen McCarthy updated everyone on events at the VA Medical Facility. The will be dedicating the new cardio clinic where they will be able to do angioplasty. The new dental building will be opening soon. To get the new Veteran ID Card, you have to go on line to vets.gov. Dr. McCarthy advised the membership that the suicide rate in the west is far greater than in the east.

Legislative Chairman Terry Araman reported that the next Legislative session is due to start January 8th. Next month he will be providing information in how to log on to the legislative calendar to information on bills pending and how to put you input.

Reggie Yates announced that the nominations are now open for next years Veterans Hall of Fame induction. The Patriotic Gala is coming up Saturday, April 4th.
