Despite their reputation as crazy, wild, high energy, biting machines, Jeanine Daugherty's two Malinois, Thrill (6 year old female) and Wow (3 year old male) take turns going to work with her at James E. Dottke High School every day. Their job is to spend time with the kids all day long. When the students with extreme anxiety need a quiet place to be with somebody who is non-judgmental, Thrill or Wow are happy to curl up on the couch with them. At the end of a long day of working, listening, and sitting still, the kids enjoy kicking a soccer ball around for the dog. Even the staff enjoys having a dog to pet after a long day. It took approximately 6 months for Daugherty to get permission, the appropriate insurance and certifications to be able to take her dogs to work.

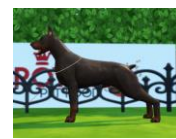
