The Hahnville citizen that came to address our membership was Wallace Brady from 168 Oak Street, Hahnville, LA 70057.

He came to discuss his wife Jonna Brady's health condition. She has a condition that is very critical and will need us to help support her. Make sure to put her on straight oxygen and monitor her vitals with the pulse ox. Information about flight care will be discussed on this – might be the best scenario in this case. The information on this will be placed in the Rescue truck# 319.

Motion by Dawn Landry, seconded by Matthew Allshouse to return to the normal agenda. Membership voted. 14 yes / 0 no. Motion does pass.

**Business Meeting:** The minutes from the January 6, 2016 Business Meeting was given to every member. Motion made by Davis Nicholas, seconded by Dwayne Tregre to accept the minute. Members voted 14 yes / 0 no.

**Board of Directors Meeting:** The minutes from the February 2, 2016 meeting was read during the Business Meeting to all members. Motion by Darren Drumm, seconded by Dwayne Tregre to accept the minutes. Members voted 14 yes / 0 no.

**Treasurers Report:** The treasurer's report for the month of January 2016 was given to every member. Motion made by Justin Ward, seconded by Dwayne Tregre to accept the treasurer's report. - Bylaws There will be a Special Board Meeting to finalize this and get them submitted on February 11, 2016 at 1830 hours.
- Discussion on Paid Employee in the Recruit Academy. Eric Rawls is doing great in the academy and working really hard. The board made a recommendation to put Eric Rawls in a hotel until the Recruit academy is over with due to living conditions at the academy. Motion by Darren Drumm, seconded by Britton Allshouse to put Eric Rawls in a hotel until the Recruit Academy is over with. This will take effective immediately. Membership voted. 14 yes / 0 no. Motion does pass.

- Discussion on Training Facility Usage Agreement. Motion by Davis Nicholas, seconded by Dwayne Tregre to allow two representatives to sign the Training Facility Usage Agreement. Membership voted. 14 yes / 0 no. Motion does pass.
- Discussion on Department issues. The board made a recommendation to the membership that anyone that gets arrested for a felony needs to be suspended immediately until further notice. This means no fire department association and needs to turn in all the items that belong to us.

Motion by Jack Landry, seconded by Davis Nicholas to suspend anyone that gets arrested for a felony immediately until adjudicated. This means no fire department association and needs to turn in all the items that belong to us. They can be re-instated with membership approval if they are adjudicated. Membership voted. 14 yes / 0 no. Motion does pass.

Discussion after motion: The membership wants to seek legal advice on this - to see if this can happen. Even if they are adjudicated and have to file as a sex offender can they still be a part of a fire department organization.

- Discussion on groups utilizing the stations. The board made a recommendation to the membership that we suspend the HHS cyber patriots group immediately from utilizing our fire stations due to lack of supervision. Motion by Britton Allshouse, seconded by Darren Drumm to suspend HHS Cyber Patriots immediately. Membership voted: 8 yes / 1 no. Motion does pass.
- Discussion on reimbursing members for medical training. Motion by Davis Nicholas, seconded by Dwayne Tregre to reimburse Darren Drumm \$70.00 for his EMT recertification training. Darren Drumm will have to supply documentation for this. Membership voted. 13 yes / 0 no/ 1 abstain. Motion does pass.
