## President's Letter

### Get Ready, Set, Go!

When the ice went out, I was ready. Ready for winter to be over and summer to begin! Then the temperature dropped and mother nature decided we needed some more snow. My enthusiasm froze. But thankfully the temps keep pushing upward, and summer is now just around the corner. I'm smiling as I count the days.

The BLCA has other news to smile about. First we received notification from the IRS that they have approved our application for a 501 (c) 3 tax status. The new status will allow us to apply for grants and programs that previously were unavailable to us. For our members it means that your membership fees and some other donations will be tax deductible. A list of which donations qualify will be posted on the BLCA website.

Next, we are moving forward on the Septic Flyover Study of the Briggs Lake Chain. One of the top concerns of lake residents is water quality. We have been testing the lakes for years, but it provides limited data. This new study will allow us to gather information to locate possible sources of lake water contamination. If we know what some of the problems are, then we can work at correcting them to improve the water quality. The company performing the flyover study, AW Research Laboratories, will be giving a presentation at the July general meeting.

Finally, I suggest you mark you calendars with this year's BLCA General Meeting dates. The general meetings are specifically for BLCA members. We start with a brief meeting to go over business of the BLCA board, including the financials, then provide updates for current activities, and end with an education program, such as the flyover study listed above. All meetings start at 10 AM and, unless specified, are held at the Palmer Township Hall. Here are the 2011 dates:

## Best Management Practices

### Clean-up, clean-up, everybody do their part.....

We are so fortunate, each year, to have the opportunity to rid ourselves of excess junk at the annual Palmer Day Spring Clean-Up. This year's event is scheduled for Saturday, May 21<sup>st</sup> from 7 AM to 2 PM at the Palmer Town Hall. It's amazing how much unwanted stuff a person can accumulate in just a year's time. What a great chance to search around your property, in the shed or garage, and get rid of some unwanted clutter or junk.

### Ice off

I'm not certain if it was due to lousy fishing reports, therefore lack of ice fishermen, but the quantity of garbage left on the ice (at least on Lake Julia) this spring was minimal. Thanks to all who disposed of their trash responsibly.

### High Water

It was interesting to witness the effect that nearly 90 inches of snow had on the lakes this year. We were treated to two floods rather than just one. Water levels may have reached record levels had it not been for the cold spell in the midst of the initial flooding. The cold temperatures allowed the lake level to recede a little bit after the initial surge came through. The water from the second wave (no pun intended) of melt off was actually higher than the first. Scary to think what could have occurred had the cold weather not slowed things up.

Unlike previous years, not a single dock section came floating by, and very minimal activity in terms of floating debris. A testament to lakeshore property owners' preparedness to the frequently occurring spring high-water levels on the lakes. With our lakes' history of flooding, it is critical to prepare your property for high water by keeping your shoreline clear of debris, and docks, lifts, and anything that might float away should be pulled out of harm's way.

Thanks to the early boaters who were respectful of the no-wake ordinance during the high water.

The water looks a little cloudy for this time of year, a likely result of shoreline erosion from the high water. Yet another good reason to consider a shoreline restoration project this season. Talk to your BLCA representative. There are grants available to assist with the cost of your project.

## Shoreland Restoration Workshop Report

On Saturday, April 23, the BLCA sponsored a Shoreland Restoration Workshop at the Palmer Township Hall. The featured presenter was Mark Basiletti from Sherburne Soil and Water Conservation District. The purpose of the workshop was to provide interested property owners around the lakes with information about conservation projects such as shoreland restorations, rain gardens, and other run-off controls to help reduce pollution of our lakes.

Mark provided background information about the watershed for the Briggs Lake Chain and Big Elk Lake and discussed the major contributors to pollution factors likely responsible for growth of algae in the lakes. An earlier two-year study of sources of phosphorus (a large factor in algae growth) showed that the upper lakes receive much of the phosphorus from the Bayou and from Briggs Creek. Big Elk's phosphorus sources are mainly from the Elk River and from Lilly Creek. Run-off from roads and lawns is also a contributing factor, and one that individual conservation projects can help reduce. Other research suggests that a 10% reduction in phosphorus levels could have a noticeable effect in algae growth. Mark also described the various ways property owners can reduce and filter run-off and showed examples of projects that have been done around the Briggs Lake Chain.

Vice-president Ken Gossett then explained opportunities for grant funding for conservation projects through the Shoreland Education and Restoration Project (SERP and SERP II) and Healthy Lakes Mini-Grants (HLMG) and described the process property owners can follow to apply for funding. SERP grants are funded through the Shoreland Habitat program of the Minnesota DNR and can reimburse property owners for up to \$2,500 for a shoreland restoration project. HLMGs are funded through a \$5,000 allocation from the BLCA Water Quality Fund and can reimburse up to \$500 per project (which may include any that would reduce run-off into the lakes—such as shoreland restorations, rain gardens, and run-off diversions).

We encourage property owners to use SERP, SERP II, and HLMG funding to help pay for a conservation project and help reduce run-off into our lakes. These projects will have a long-term benefit in improving the water quality of our lakes. BLCA volunteers will help with planning, grant application, and actual labor for planting. 
